Rules of Decorum.

- 1. The Association shall be opened and closed with prayer.
- 2. A Moderator and Clerk shall be chosen by the members
- *3. Only one person shall speak at a time, who shall arise and address the Moderator by the appellation of Brother Moderator, and shall while speaking confine himself to the subject under consideration and shall not be interrupted unless he digress from the subject, and shall in no wise reflect on any other speaker, so as to make remarks on his slips, failings, or imperfections, but shall fairly state his views without sophistry or criticism.
- 4. No member shall absent himself from the Association without leave of the Moderator.
- 5. No member shall speak more than three times on the same subject without leave of the body.
- 6. Every motion and second shall come under immediate consideration of the Association, unless withdrawn by the one who made it.
- 7. No member shall whisper, laugh, or read any book or paper while the Association is in session.
- 8. No member shall address another by any other appellation than that of Brother.
- 9. On the second day it shall be the duty of the Clerk to read the Rules of Decorum and call the roll of members.
- 10. The Moderator shall be entitled to the same privilege of speaking as any other member, provided the chair be filled; but shall have no vote unless the Association be equally divided.
- 11. Any person violating these rules, or at any time manifesting a spirit contrary to the Gospel shall be reproved, or such other course taken with him as the Moderator may think proper, either at his own option or the intimation of any other member.

The committee on Prohibition read their report as follows:
We are glad to report that since the last meeting of our Association the Legislature of Tennessee has passed State-wide prohibition laws, which have abolished every saloon from Tennessee, since July 1, 1909, and which will abolish every distillery and brewery after Jan. 1, 1910. The legalized liquor traffic has gone from Tennessee, thank God, and it has gone forever.

The question now is the enforcement of these laws. To insure their enforcement we recommend (1) that we lend all our sympathy and influence to those whose duty it is to enforce the laws. (2) that for all offices, executive, judicial and legislative we will vote only for such candidates as will openly declare their sympathy with these laws and their determination to enforce them to the best of their ability. (3). That at the coming legislative campaign we will vote only for such candidates as will declare themselves in favor of maintenance and enforcement of these prohibition laws and who favor such additional legislation to enforce the present laws.

NIGHT SESSION.

After a most excellent sermon by Brother J. M. Phillips, of Lebanon, the Association resumed business and Brother Hudgins read the report on Sunday School and Colportage work in the State as follows:

on Sunday School and Colportage work in the State as follows:

We, your Committee on Sunday School and Colportage, beg leave to submit the following: We recognize the Sunday School as the teaching service of the church and urge that it be so considered. Christ went about teaching in the synagogues and preaching the Gospel of the kingdom. (Matt. 5:13). "Go ye therefore and teach all nations • • teaching them to observe all things whatsoever I have commanded you." (Matt. 23:13-20). We believe the Scriptures and beg that we work up to the demands now upon us and fall into line with the great Sunday School work now engaging the attention of Christendom. We recommend the organization of the State by Associations and ask that a Superintendent be elected for this Association and instructed to organize a convention and hold an institute each year, where teachers and workers may come together for self-improvement. We also suggest the appointment of as many as four helpers to aid in the work. We also call attention to the excellent work being done by the Baptist Encampment at Estill Springs. We also recognize the Colportage work as most important. The Colporter's work cannot be overestimated, as he goes from house to house selling books and preaching the Gospel. He comes in touch with people who cannot be reached at church. Your Colporters here have submitted good reports of work done. Let the work go on. Brother Summar has sold many books, Bibles, preached, held some meetings and numbers have been converted and baptized. To the work, brethren of Wiseman Association.

STATE OF RELIGION.

The Committee on State of Religion reported as follows: There has been one hundred and sixty-nine additions to our churches by experience and baptism during the past year, which is an increase of seventy-six over the previous year. Many of the churches haven't held their annual meeting, which, doubtless, would increase the additions to our churches. We are sorry so few of our churches report Sunday Schools and prayer meetings. We earnestly recommend that our pastors organize Sunday Schools and prayer meetings in all our churches and press upon our folks the necessity of these things. We need to bestir ourselves and work for the things which will insure a healthy spirituality in our churches. We suggest as a healthy suggestion for the improvement of the State of religion a rigid discipline be enforced

The Committee on Religious Literature reported as follows: "Reading makes a full man," said Lord Bacon. Full of what? It depends upon what he reads. If he reads good literature he will be apt to be full of good thoughts, good words, good deeds. If he reads bad literature he is apt to be full of bad thoughts, bad words and bad deeds, it becomes very important, therefore, that we read only literature of a pure and helpful character, which will have a wholesome influence upon us. We recommend literature worthy to be read by members of this Association—the Bible, of course, first of all, which we are sorry to believe is sadly neglected; the books and literature published by our various Baptist publishing houses, the literature of the Sunday School Board at Nashville, the Baptist and Reflector, Home and Foreign Mission Journal and all other sound Baptist literature.

At this hour James Henry Oakley was asked to preach in the methodist house of worship to the overflow crowd which packed the building and a sermon on "Missions" was delivered to the delight of the people.

The reports on State, Home and Foreign Missions were read as follows:

STATE MISSIONS.

By State Missions is meant the co-operative work of the churches through the State Board appointed by the Tennessee Baptist Convention. This Board is submitted by a nominating committee and elected at each session of the convention. It consists at present of thirty-four brethren, distributed throughout the State. This Board or Committee on Missions for the State organized for work, with headquarters at Nashville. W. D. Golden is its Missionary Secretary and W. M. Woodcock Treasurer. It is the business of this Board and its officers to conduct missionary work in Tennessee between the sessions of the conventions. Missionaries and Colporters are employed upon the approval of their local churches or executive boards of their Associations. The Board submits through its Secretary and Treasurer annual reports of work dene. To give some idea of the work being done by our State Board of Missions we take the following items from Brother Golden's last year's report. Missionaries and Colporters employed 96, days of labor 13,810, stations supplied regularly and irregularly 1,105, sermons and addresses 11,840, professions of faith 3,290, baptisms 1,540, total additions 2,874, churches built, improved and put into service 96, at a cost of \$19,676, Sunday Schools organized 99 with an enrollment of 4,010 and other items could be mentioned.

To secure these results the churches contributed \$15,687. There are in Tennessee 1,608 white Baptist Churches, only 693 contributed last year to State Missions, leaving 915 churches claiming to be Missionary Baptists, who gave nothing through this co-operative work. In Tennessee we have 100,000 white Baptists, 32 Associations. Wise-

man Association is one of the thirty-two and is constituted of twenty-two churches. Only eight of these churches gave one cent to State Missions and this the small sum of \$60.00. Brethren, we must surpass these figures the coming year. Foreign and Home Missions have both doubled State Missions in our Association. We ask not for a falling off in Foreign and Home Missions, but a pushing forward in our State Mission work. While our zeal runs toward the lost millions in the regions beyond let us not be forgetful of the thousands sinking into a starless night at our own doors. The fields are white as white can be and much we are losing every day for men to work and pray.

FOREIGN MISSIONS.

We, your Committee on Foreign Missions, submit the following report: For a foundation upon which we shall build this report we refer you to 2 Cor. 8:9, "though he was rich, yet for your sakes he became poor, that ye through his poverty might be rich." In the beginning of time God planned and ordained that he would redeem the world through missions. Christ was as a lamb slain from the foundation of the world. In 1 Pet. 1:19, 20, "But with the precious blood of Christ, as a lamb without blemish and without spot: who verily was foreordained before the foundation of the world but was manifest in these last times for you." Nearly two thousand years ago Christ while upon earth organized his church, to which he gave a great command. Matt. 28:20, records the commission as follows: "Go ye, therefore, and teach all nations, baptizing them in the name of the Father, of the Son, and of the Holy Ghost: teaching them to observe all things whatsoever I have commanded you; and, lo, I am with you alway, even to the end of the world."

The question arises, "where shall the church witness or send missions will teach us to believe in Foreign Missions. Acts 1:8 reads, "But ye shall receive power, after that the Holy Ghost is come upon you; and ye shall be witnesses unto me both in Jerusalem, and all Judea, and in Samaria, and unto the utmost part of the earth." Paul writing to the church at Rome says, "How then shall they call on him in whom they have not believed? and how shall they bear vithout a preacher? and how shall they preach except they be sent? As it is written, "How beautiful are the feet of them that preach the Gospel of peace, and bring glad tidings of good things."

Brethren, the commission is to us. While we have missionaries in Japan, China, Africa, India, Italy, South America, Mexico, Cuba and Australia, we realize we have not half enough. Heathens are lost with out the Gospel, and the Lord said for us to blow the trumpet and

We commend the resolution of our State Convention to co-operate with Kentucky Baptists in the establishment of such a home. Carson and Newman College, located at Jefferson City in East Tennessee, enjoyed the most prosperous session of its history last year, having reached the high watermark of more than five hundred stu-

dents. The same encouraging report comes from Hall-Moody Institute at Martin, Tenn. This institution has nad a phenomenal growth for a young institution, having enrolled last year more than five hundred students. Union University, Jackson, Tenn., has not been quite so prosperous, but we are glad to see signs of growth and returning prosperity. The future is bright. The Tennessee College for Women, Murtreesboro, Tenn., the youngest Baptist Institution of learning in the State, is a great success, the enrollment being upwards of two hundred young women and still they come. All these schools are doing excellent work and richly deserve the patronage and support of our Baptist people. Each needs strengthening to be equal to the work forced upon them. With hundreds and thousands of students in our Baptist institutions of learning, we should lend our loyal support to them.
