Permanent organization was effected by the election of Brother A. J. Sloan, Moderator; Brother W. J. Johnson, Assistant Moderator; T. C. Harrison, Clerk; G. W. Jenkins, Assistant Clerk; J. D. Cook, Treasurer, and W. J. Summar Assistant Treasurer.

Next Place of Meeting.

Dixon Creek, two miles north of Dixon Spring, was selected as the next place of meeting of the Association on Wednesday after the third Sunday in October, 1917.

Elder A. J. Sloan was selected to preach the introductory sermon, W. J. Summar, alternate; Elder A. J. Stone the doctrinal sermon, and P. S. Dyer alternate.

Brother A. J. Sloan was elected delegate to the Southern Baptist Convention, Elder W. J. Summar, alternate, which meets, and Elder W. J. Summar was elected delegate to the State Convention, which meets; P. S. Dyer, alternate.

On motion it was ordered that any of the brethren visiting any other Association shall have the power to represent us in all the Associations they may attend.

The Association then adjourned until Thursday morning at 8:30 o'clock Prayer by J. H. Overton.

SECOND DAY

The Association met pursuant to adjournment after singing and prayer by Brother William Jenkins.

After roll call and reading of the rules of decorum by the Clerk the Association proceeded to the regular order of business.

On motion it was ordered that each speaker be limited to ten and five minutes each on each subject.

Constitution.

Article 1. This body shall be known as Wiseman Association.

Article II. These Associations shall be composed of members duly chosen by regular and orderly Missionary Baptist churches within our bounds.

Article III. The letters from the churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated and dead since last annual letter.

Article IV. Each church shall be entitled to three Messengers.

Article V. These Associations shall elect annually to offices a Moderator, Clerk and Treasurer, whose duties shall be to serve their brethren in their several capacities.

Article VI. These Associations shall never interfere with the independence of any church, or claim any ecclesiastical powers or rights of supervision over any of the churches.

Article VII. It shall be the object of these Associations to promote the union of the faith of the Gospel with our educational and mission interests.

Article VIII. These Associations shall meet annually on Wednesday at 10 o'clock a.m., after the third Sabbath in October, and continue three days, the meeting to be held at such places as may be agreed upon by the Association in its annual sitting.

Article IX. A majority of the members of any regular meeting shall constitute a quorum for the transaction of business.

Article X. It will be expected that these meetings will be missionary in practice as well as in theory.

Article XI. New churches may be admitted into this Association who shall petition by letter and delegate or delegates, and on examination, if found orthodox and orderly, may be received and made known by the Moderator giving the right hand of fellowship to the delegate or delegates present.

Article XII. The Association may exclude from union any church or churches that are heterodox in principles or disorderly in practices.

Article XIII. The Association, at its sittings, may admit any other sitting brethren present to sit with them, who snall nave liberty to discuss any question and give light, but not to vote, except on subjects of general union.

Article XIV. Any alteration may be made to this Constitution at any regular annual meeting by a two-thirds vote of the members present.

Rules of Decorum.

- 1. The Association shall be opened and closed with prayer
- 2. A Moderator and Clerk shall be chosen by the members present.
- 3. Only one person shall speak at a time, who shall arise and address the Moderator by the appelation of Brother Moderator, and shall, while speaking, confine himself to the subject under consideration and shall not be interrupted unless he digress from the subject, and shall in no wise reflect on any other speaker so as to make remarks on his slips, failure, or imperfections, but shall fairly state his views without sophistry or criticism.
- 4. No member shall absent himself from the Association without leave of the Moderator.
- 5. No member shall speak more than three times on the same subject without leave of the body.
- 6. Every motion and second shall come under the immediate consideration of the Association, unless withdrawn by the one who made it.
- 7. No member shall whisper, laugh, or read any book or paper while the Association is in session.
- 8. No member shall address another by any other appellation than that of brother
- 9. On the second day it shall be the duty of the Clerk to read the Rules of Decorum and call the roll of members.
- 10. The Moderator shall be entitled to the same privilege of speaking as any other member provided the chair be filled, but shall have no vote unless the Association is equally divided.
- 11. Any person violating these rules, or at any time manifesting a spirit contrary to the Gospel shall be reproved or such other course taken with him as the Moderator may think proper, either at his own option or the intimation of any other member.


