#### FIRST DAY

#### WEDNESDAY, JULY 13, 1932

The Wiseman Baptist Association met in its forty-first Annual Session with the Baptist church at Siloam, two miles east of Westmoreland, Tennessee, at ten o'clock a. m. Services were opened with singing "I Am Bound For the Promised Land," and "Savior, More Than Life." Prayer was offered by Elder Alfred Cook, followed by singing. The Moderator, Elder L. A. Stewart, and the assistant Moderator, Elder N. C. Fuqua, both being absent, the clerk, Elder A. J. Sloan, called the Association to order. Elder A. G. Stinson was appointed as temporary moderator. After several remarks, Eld. Stinson read as a lesson, the 121st Psalm and then offered prayer. Song, "The Life Boat," was then sung. Elder Stinson then presented Elder R. Thompson, the appointee of last year, to preach the Introductory Sermon. Brother Thompson offered several remarks and then chose for a text 1 Tim. 4:16, his theme being "The Doctrine." At the close of the discourse, the congregation sang and pressed forward to give their hand to the minister in token of their endorsement of the sermon.

Elder N. C. Fuqua, the assistant moderator, having arrived, the work of Elder Stinson was turned over to Elder Fuqua. He appointed as reading clerks Elder Calvin Gregory and Brother W. H. Smith.

#### PLACE OF MEETING

The question of the next meeting place of the Association was taken up, Old Hopewell and Rocky Mound churches having asked for our next session. After a number of speeches had been made in favor of each place, the Association voted overwhelmingly to meet with Rocky Mound church, seven miles northeast of

Westmoreland, Tennessee, in 1933. Elder W. T. Taylor was selected to preach the next Introductory Sermon with Elder L. A. Stewart as alternate. Elder A. J. Sloan was chosen to preach the next Doctrinal Sermon, with Elder N. C. Fuqua as alternate.

At this point the Committee on Divine Service announced that Elder L. A. Stewart would preach at this place tonight. Homes were next assigned to the messengers and visitors. Moved to adjourn to meet at eight-thirty o'clock in the morning. Dismissed with prayer by Elder G. L. Hughes.

#### WEDNESDAY NIGHT

A large congregation assembled at eight o'clock for preaching. Elder Lewis Mince led in prayer, after which Elder L. A. Stewart chose for a text Psalm 34:7 and preached a fine sermon on "How the Angels Care For God's Children." At the close of the discourse, the congregation sang and some shouted their praises of God and felt that it was good to be there.

# SECOND DAY THURSDAY MORNING

The Association assembled with singing. Prayer was offered by Elder L. A. Stewart.

After the calling of the roll of messengers and the reading of the minutes of yesterday, the Moderator announced the Association ready for business.

The report on Religious Literature was read by Elder L. A. Stewart as follows:

### RELIGIOUS LITERATURE

How can we as a people expect to accomplish much unless we read and know something of what Baptists believe. We have been fortunate in the past to have sound Baptist papers for our people to read, but we are sorry to say that at present sound Baptist papers are few in numbers. Much unsound and misleading literature is being read by our people at this time.

The literature that people read often determines their beliefs. As we read, we think; and as we think, we act. We urge our people to read sound literature. We would recommend first our own paper, the Baptist and Commoner, which should be in the home of every Baptist family. We also recommend any other papers that are sound in the faith. L. A. STEWART,

The report on Ministerial Education was read by Elder F. W. Lambert as follows:

#### MINISTERIAL EDUCATION

We, your Committee, submit the following report: Education means to draw out and develop the talents and powers of man, mentally, morally and spiritually. Our ministers should study the word of God with a prayerful desire to understand it. David said: "Open thou mine eyes that I may behold wondrous things out of thy law."

We recommend that our ministers study Ray's Baptist Succession and Grime's History of Middle Tennessee Baptists, as well as all other good books that will prepare them for their greatest usefulness as ministers of the Gospel. They should avail themselves of every opportunity to secure a good literary education. They need a practical understanding of the use of language and the meaning of words that they might the more readily understand the Scriptures and be more able to meet the critics of modern times. Paul told Timothy to "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." James tells us that "If any man lack wisdom, let him ask of God who giveth to all men liberally and upbraideth not." There is no safer and sweeter place to learn the truth than at the feet of the great teacher, Jesus, whom we may approach in humble prayer. The man with an open Bible and an honest desire to know the truth will always feel safe amid the storms of earth. Prayerfully submitted,

#### THURSDAY AFTERNOON

The Association came together with singing, followed with prayer by Elder A. G. Stinson. The following visitors were enrolled at this point:

The report on Fundamental Doctrines was read by Elder A. G. Stinson as follows:

#### FUNDAMENTAL DOCTRINES

- 1. We believe that there is only one true and living God, the Father, Scn and Holy Spirit.
- 2. We believe that the Holy Bible was written by men divinely inspired of God.
- 3. We believe that the Scriptures of the Old and New Testaments are the written word of God and the only rule of faith and practice.
- 4. We believe that the Scriptures teach that man was created in holiness under the law of his maker; but by voluntary transgression, he fell from that holy and happy state.
  - 5. We believe that God calls men to preach the Gospel.
- We believe that the Gospel must be preached to the world, and that sinners must hear the Gospel and repent of their sins or be lost forever.
- 7. We believe that the Scriptures teach that the salvation of sinners is wholly of grace through faith.
- 8. We believe that God's elect are those who are called of God, and whom He called, He also justified; and whom He justified, them He also glorified.
- 9. We believe that a child of God is one who has been born of the Spirit of God, and that he will persevere through grace and never finally fall away and be lost; but is kept by the power of God.
- 10. We believe that the Scriptures teach that Missionary Baptist churches are the true churches of Christ. A visible church has Christ for its head and not man.
- 11. We believe that Christ gave the commission to His church and His church only, to teach all nations.
- 12. We believe that the Scriptures teach that Christ gave Baptism and the Lord's Supper as ordinances in the church.
- 13. We believe that true believers are the only proper subjects for baptism and that the only proper mode of baptism is immersion.
- 14. We believe that the Scriptures teach that the Lord's Supper can be taken only in the churches of Christ, and that members of such churches only have the right to partake of the Supper.

This report was adopted after discussion by A. G. Stinson and Lewis Mince.

The report on Missions was read by Elder A. J. Sloan as follows:

#### MISSIONS

Article 2 of the Constitution of Wiseman Association says: "These Associations shall be composed of members duly elected by regular and orderly Missionary Baptist churches within our bounds." Article 7 says: "It shall be the object of these Associations to promote the union of the faith of the Gospel with our educational and mission interests." Article 10 says: "It is expected that these meetings will be missionary in practice as well as theory."

From these three articles we learn that the framers of the Constitution of the Association had in mind the promotion of missions as one of the objects for which our union was formed a little over forty years ago. That we have departed from the original purpose of this union, so far as missions are concerned, is evident to those who heard the various letters read. From these we learn that only four of the churches of Wiseman Association gave a cent to missions of any kind during the past year. These four gave less than \$20. It seems very sad to depart from the practice of those who went before us in living obedient Christian lives. If these good old men and women of other years could see how little we are doing, they would understand that we have departed from the spirit of former times.

While it may seem bad to go back on those who labored before us, it is not the hundredth part so serious as going back on what the Bible teaches. The word of God shows that the whole scheme of human redemption is after the missionary order. The first preacher of the New Testament, John, the Baptist, was a missionary, a man sent from God on a mission. The next preacher of the New Testament was Jesus Christ, and He was a missionary sent from God to the lost world. Jesus sent out the apostles as missionaries to the lost sheep of the house of Israel, and later sent them out under a commission to go to the nations of the earth with the missionary message. God called Paul and sent him as the missionary to the Gentiles. Missions means the spread of the Gospel and includes all the Scriptural means thereto. All our members are not situated so as to be able to go to mission fields, but nearly all of them could aid in the work by contributing of their means for the spread of the truth. About the only mission work done by any member of the Association during the past year, except for the contributions from the four churches mentioned above, was that of sacrificing ministers who went into destitute places and preached the word of God without money and

without price. We bid such men Godspeed, but do you suppose that God would have these ministers to give of their time, their strength and bear their own expenses and at the same time require nothing of the great body of the membership of the twenty-eight churches in Wiseman Association? Why not have a part in doing mission work here in our bounds? Why not help the men of God to bear a part of the heavy sacrifice required of them?

Let our ministers preach the truth of the Bible on missions. Let the people know what God says and what He demands of His children in the spread of the Gospel. Let the man of God know that you will help him with your prayers, your moral support, your encouragement and your money. Let us be missionary Baptists in deed as well as name. May God help us to lift up our eyes to the fields that are already white unto harvest. May He enable us to carry the old, old story of the cross to the perishing millions of a lost world.

The report on Pastors' Support was read by Elder A. J. Sloan as follows:

#### PASTORS' SUPPORT

We know that the churches of Wiseman Association are not doing their part toward their pastors. In the first place, they are not paying the pastors for their labor. In the second place, they are blaming their pastors with not knowing how to explain the word of God to them. Churches, please pay your pastor so that he may give his time to the study of the word and not have to put in all his time trying to make a living by work other than the ministry. He is commanded by the Lord to study to show himself approved of God. 2 Tim. 2:15. Do you think you could live on four or five dollars a week, run your car forty or fifty miles to get to the church and then have to go many more miles to funerals and other places to which the minister must go? God holds you responsible for withholding from the man of God when you rob His faithful servant. Don't you know that God has given you what you have in this world? And He expects each member to give a part of what he has to the cause of the Lord. This applies not to the men enly, but to the women as well. Let us try to do more during the next year for our pastors.

It was also agreed to leave off one day of the Association, having the Doctrinal Sermon on Thursday instead of Friday as heretofore.

Moved to adjourn to meet with Rocky Mound church, seven miles northeast of Westmoreland, Tennessee, on Wednesday after the third Sunday in October, 1933. Dismissed with prayer by Elder W. M. Norman. Thus closed one of the very best sessions of this Association.

#### RULE OF DECORUM

- 1. The Association shall be opened and closed with prayer.
- 2. A Moderator and a Clerk shall be chosen by the members present.
- 3. Only one person shall speak at a time, who shall arise and address the Moderator by the appellation of Bro. Moderator, and shall, while speaking, confine himself to the subject under consideration and shall not be interrupted unless he digress from the subject and shall in no wise reflect on any other speaker, so as to

make remarks on his slips, failings, or imperfections, but shall fairly state his views without sophistry or criticism.

- 4. No member shall absent himself from the Association without leave of the Moderator.
- 5. No member shall speak more than three times on the same subject without leave of the body. The chairman on each subject shall have an opening speech of ten minutes and two other speeches of five minutes each. All other speakers shall be limited to three speeches of five minutes ach.
- 6. Every motion and second shall come under the immediate consideration of the Association, unless withdrawn by the one who made it.
- 7. No member shall whisper, laugh or read any book or paper while the Association is in session.
- 8. No member shall address another by any other appellation than that of Brother.
- 9. On the second day it shall be the duty of the Clerk to read the Rules of Decorum and call the roll of members.
- 10. The Moderator shall be entitled the same privilege of speaking as any other member, provided the chair be filled; but shall have no vote unless the Association be equally divided.
- 11. Any person violating these rules, or at any time manifesting a spirit contrary to the Gospel, shall be reproved, or such other course be taken with him as the Moderator may think proper, either at his option or the intimation of any other member.

#### CONSTITUTION

Article I. This body shall be known as Wiseman Association. Article II. These Associations shall be composed of members duly chosen by regular and orderly Missionary Baptist Churches within our bounds.

Article III. The letters from the Churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated, and dead, since last annual letter.

Article IV. Each Church shall be entitled to three messengers.

Article V. These Associations shall elect annually as officers, a Moderator, Clerk, and Treasurer, whose duties shall be to serve their brethren in their several capacities.

Article VI. These Associations shall never interfere with

the independence of any Church, or claim any ecclesiastical power or rights of supervision over any of the Churches.

Article VII. It shall be the object of these Associations to promote the union of the faith of the Gospel with our educational and mission interests.

Article VIII. These Associations shall meet annually on Wednesday at 10 o'clock a.m., after the third Sunday in October, and continue two days, the meeting to be held at such places as may be agreed upon by the Association at its annual sitting.

Article IX. A majority of the members of any regular meeting shall constitute a quorum for the transaction of business.

Article X. It is expected that these meetings will be missionary in practice as well as theory.

Article XI. New Churches may be admitted into this Association, who shall petition by letter and messengers, and on examination, if found orthodox and orderly, may be received and made known by the Moderator, giving the right hand of fellowship to the Messenger or Messengers present.

Article XII. The Association may exclude from union any Church or Churches that are heterodox in principles or disorderly in practice.

Article XIII. No proceedings shall be had against any Church except upon charges preferred by a sister Church, which shall first have followed the direction of Matthew 18:15, in attempting to bring it to repentance.

Article XIV. The Association at its sittings may admit any other visiting brethren present, to sit with them, who shall have liberty to discuss any question and give their views but not to vote except on subjects of general union.

Article XV. Any alteration may be made to this constitution at any regular meeting, by a majority vote of the members present.

# ABSTRACT OF PRINCIPLES OF WISEMAN ASSOCIATION OF BAPTISTS

We, the Missionary Baptists of Christ, being regularly baptized upon the profession of our faith in Christ, are convinced of the necessity of a combination of the churches in order to maintain the general union and communion among ourselves; and being convinced that there can be no communion without union, we think it our duty to set forth in a concise manner the grounds upon which we propose to maintain this union.

- 1. We believe in one true and living God, the Father, the Son and the Holy Spirit.
  - 2. We believe that the Scriptures of the Old and New Testa-

ments are the word of God, and that they are the only rule of faith.

- 3. We believe in the doctrine of election, according to the foreknowledge of God, through sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ.
- 4. We believe in the doctrine of original sin and in man's impotency to recover himself from the fallen state he is in by nature of his own free will and ability.
- 5. We believe that sinners are justified in the sight of God by the imputed righteousness of Jesus Christ.
- 6. We believe in the final preservation of the saints, that they will never finally fall away and be lost, and that good works are fruits of faith and follow after justification.
- 7. We believe that baptism and the Lord's Supper are ordinances of Christ, and that they were given to the Church by Him; and that true believers are the only proper subjects for baptism, and that baptism is an immersion, and that orderly members of the Churches of Christ, only, have a right to the Lord's Supper.
- 8. We believe that no minister has a right to administer the ordinance except such as are regularly baptized and come under the hands of the Presbytery.
- 9. We believe in the resurrection of the dead and a general judgment, and that the joys of the righteous and the punishment of the wicked will be eternal.
