PROCEEDINGS FIRST DAY, FRIDAY, OCTOBER 24, 1969

The seventy-eighth annual session of Wiseman Baptist Association convened with Faith Missionary Baptist Church, Rose and Burbank Streets, Nashville, Tennessee, beginning Friday, October 24, 1969

Services were opened at 10:00 A. M., with singing led by Eld. Wesley Briley. The songs "The Gloryland Way" and "The Old Country Church On The Hill" were sung and prayer was offered by Eld. H. C. Vanderpool, Clerk of Siloam Baptist Association.

After the prayer, the song, "Have You Really Been A Friend To Him" was sung, and after some opening remarks, the acting Moderator, Elder F. L. Ray, read the first two verses of the 12th chapter of Hebrews and asked Eld. E. J. Baker of Southwestern District Baptist Association to lead in another prayer.

Another song, "Each Step I Take" was sung and Brother Ray presented Eld. Harold Dean Linville, the appointee of a year ago, to preach the Introductory Sermon.

After some preliminary remarks, Brother Linville read for a scripture lesson the second epistle of John and chose the 8th verse for his text, "Look to yourselves that we lose not those things which we have wrought, but that we receive a full reward."

By many scriptures he called attention to the many precious truths embodied in the faith of true Baptist that have been preserved by them, showing the Baptist Church to be one that Jesus built and the only institution obligated to God to preserve the truth to all generations.

Brother Linville stressed by the scriptures, with much zeal and power, the necessity of unity in the truth with brotherly love that God's power may continue to be known and felt among His people.

His good, strong, sound and very timely sermon was well received with many hearty amens during his discourse, and in endorsement thereof the congregation extended to him their encouraging hands while a number of songs were being sung.

At this time, the letters from the various churches were filed with the Clerk, and Elders H. C. Vanderpool and Calvin Perrigo were appointed as reading clerks.

A motion was made to adopt the report, and the Moderato called for a song, after which he presented Brother Taylor, the appointee of a year ago to preach the Memorial Sermon.

Following some remarks, Brother Taylor read for a lesson Act. 26:12-23 and chose for a text Job 14:14, "If a man die shall he live again?"

He pointed out the certainty and reality of death, showing that this is the land of the dying and not the land of the living; that both saved and unsaved must die as it is appointed unto all men, but that God has provided for the resurrection of both the saved and unsaved.

No doubt, we are living in the perilous times that Paul spoke about in the third chapter of Second Timothy. Also the falling away that he pointed out in 2 Thess. 2:3, and many other scriptures that tell us about these evil days that we are living in now.

There has never been so much to contend with in our life time. People who claim to be Baptist are believing and practicing almost any and everything but the truth.

The Convention Baptist, North American Baptist, American Baptist are all just about on the same level when it comes to faith and practice.

We have the National Council of Churches, the Ecumenical movement, with every other false doctrine and practice.

We believe the Bible to be the only true rule of faith and practice, and we can find the things that we should believe, teach and practice in the Bible. When we say, the Bible teaches certain things, we mean that they can be found by precept, command or example.

We have the Articles of Faith that all our churches have adopted, that set forth in a condensed manner what we believe the Bible to teach.

We are told by Jude, to earnestly contend for the faith that was once delivered to the saints. We can do this by expounding the doctrine, and then practice what it teaches.

There is much unrest among our old-time Baptist Churches now concerning the practice of alien baptism. And we have some among

us who are in sympathy with such practice, and they are digging up irregularities of the past to try to justify themselves in their irregular practice.

Our position is, that we accept those things that we cannot correct, and live with them the best we can, and correct those things that can be corrected, and ask the Lord to give us grace, strength courage and wisdom to be more watchful and strict in the future.

It is disappointing to see the weakness manifested in some that we thought to be strong in the faith, and that would take a stand for the truth.

The church at Antioch, and the church at Jerusalem had some differences concerning false doctrine, and they got together and cor rected their troubles. You may find this in the fifteenth chapter of

Paul called on the church at Corinth to make corrections of a number of things, which example, I believe, that churches of toda should follow.

The Lord called on the churches of Asia, to make corrections of their false doctrines and practices. One of them had lost her first love, one had a woman preacher or teacher, one was holding the doctrine of Ba-laam, and the doctrine of the Nicolaitanes and another works were not satisfactory to the Lord.

We believe that God is still looking down on His churches. He still knows all the works that are going on in them, and if ther is anything wrong that can be corrected, we believe it should be corrected as soon as possible.

- 15. Do you personally tell your friends and neighbors about Christ 16. Are you uncomfortable when you talk to people about their soul
- 17. When you have sinned, do you attempt to justify your action If so, why? by putting the blame on someone else or do you confess you sin to God and ask His forgiveness?

30. Considering these questions and possibly others which have come to your mind, what do you think the "State of Religion" is in your home and in your church?

The time having arrived for the preaching of the Doctrinal Sermon, a song was called for and the congregation stood and sung "Sweeter Each Day", after which Bro. Taylor presented Eld. W. T. Russell to preach the Sermon.

Brother Russell read the fifty third chapter of Isaiah and used verse 6 for his text, "All we like sheep have gone astray, we have turned everyon to his own way, and the Lord has laid on him the iniquity of us all."

He began his sermon by saying that man's fall from a state of holiness to utter separation from God, the state of man through the ages and the true way of man's redemption and way back to God has been, and is today a basic doctrine of Baptist. Also, that in modern day teaching and practice is dangerously misleading.

He showed the Bible to teach, and Baptist believe and teach that Adam was created holy in the sense of being pure and without guilt before God, but that this holiness was finite and not infinite as infinite holiness belongs only to God. Since he was finitely holy he possessed the capability of sin. Also, he possessed the capability of keeping God's law which was proven by being able to resist that which God had forbidden for a period, the length of which we know not, that he spent in the garden of Eden.

Brother Russell showed Adam to be made in the likeness and image of God in the sense that he was created an intelligent and spiritual being, and where there is intelligence there is responsibility. That Adam was not deceived into transgressing God's law as Eve, but did voluntarily and willingly sin against God, knowing the consequences that it meant death in the sense of separation from God. And he being head of the human race, we all sinned it Adam. He showed that Eve was an offspring of Adam just as was Cain and Abel and that the responsibility for the whole human race rested in Adam.

From this was shown that God provided a saviour identified at the seed of the woman, made of a woman, not of man, that Jesu having God for his father and not a son of Adam inherent depravit was by-passed and a suitable Saviour was provided and in ever way qualified to honor the law of God by paying the debt against Adam and satisfy God.

Brother Russell read and used the third, fourth and sixth a ticles of faith showing what Baptist declared as their belief, and that had it not been for the Baptist the basic doctrine of inherent depravity would have been lost long ago, which is that man, had nature, is utterly void of that holiness required by the law of Go positively inclined to evil; and therefore under just condemnation the ternal ruin, without defense or excuse.

He showed that Baptist believe the only way boak to God by faith in Jesus Christ and His shed blood, that being sinners I nature that God is offended and has commanded all men ever where to repent, trust in Jesus Christ and experience that new bir of the spirit, without which, Jesus said, you cannot enter into the kingdom of heaven.

In closing, he showed by the seventh article of faith that Bapti declare that they believe, that in order to be saved, sinners mube regenerated, or born again; that regeneration consists of giving a holy disposition to the mind; that it is effected in a manner about comprehension by the power of the Holy Spirit, in connection with divine truth, so as to secure our voluntary obedience to the go pel; and that its proper evidence appears in the holy fruits of a pentance, and faith, and newness of life.

He pointed out that in man's salvation he was blind to spiritu

things and was commanded to seek the Lord, feel after Him and find Him, that there is Godly sorrow in the heart of the sinner which works repentance unto salvation which comes by a trusting faith in Jesus, and that old-fashioned Baptist maintain the safe way and scriptural way of practcie in providing the convicted soul the altar place where they can pray and we can pray with them for the salvation of their souls.

After the sermon, the crowd pressed forward and gave Brother Russell their hand of endorsement, and engaged in a Christian handshake with one another while the songs, "Amazing Grace" and "Where The Soul Never Dies" were sung.

A motion was made to adjourn one hour for dinner. After announcements, the benediction was offered by Bro. Wilburn Harrison.

SUNDAY AFTERNOON

After enjoying another wonderful dinner which has been suplied every day in abundance, the afternoon service was opened with singing, "Standing On The Promises," after which prayer was offered by Eld. B. G. Sutton. The song, "When We All Get To Heaven" was sung and the regular order of business was taken up and the report on Temperance, Morality and Church Discipline was called for and there being no response, a motion was made that the report written last year be adopted.

NEW BUSINESS

The appointment of a trustee of the Orphans Home was taken up, and, by motion, Eld. F. L. Ray was recommended to the trustees for re-election to another three-year term as trustee of the Orphans Home.

RESOLUTION

The following Resolution was read by Eld. W. T. Russell as follows:

WHEREAS, at the General Association of Missionary Baptists which met in Nashville, Tennessee, on Saturday, March 29, 1969, a resolution was adopted respecting some irregularities existing within Baptist Churches on our boundaries, and

WHEREAS, the points of this resolution being strict adherance to and scriptural observance of the two ordinances, baptism and the Lord's Supper, and

WHEREAS, it is a known practice in some Baptist churches to receive candidates for baptism by what they call accepting Christ or making a decision, with repentance no longer a requirement neither an experienc of grace, and

WHEREAS, we are convinced that old-fashioned Baptist in belief and practice are being inconsistan twhen we continue to correspond with these churches which we consider out of order in their practice and and cannot and will not conscientiously work with these churches in their meetings on their terms of practice. Yet, we virtually endorse their practice when we seat them in our meetings, receive their letters, invite them to observe the Lord's Supper with us as well as recognize and seat them in our association, and

WHEREAS, due to this inconsistancy on our part we feel that many young christians as well as outsiders are confused and wonder why we contend for the old-fashioned altar, believe in genuine repentance and an experimental knowledge of salvation, and require every candidate for baptism to tell publicly of his or her travels from nature to grace, when at the same time we continue to correspond with these churches whose practice we condemn; therefore.

BE IT RESOLVED:

That we show the world that we are determined to be consistant in faith and in order, in doctrine and practice.

2. That we acknowledge that we have neglected to adhere strictly to the phrase, "of the same faith and order" in our correspondence with other Baptist churches.

3. That we make inquiry into the practice of churches, about which we do not know, as to their requirements of candidates for baptism upon receiving and granting letters.

4. That each candidate for membership in our churches be required to give evidence of a change of heart (an experience of grace) regardless of how they come to us, by letter, credit of letter as well as for baptism.

That we refrain from seating in our association, and in our business meetings members of churches which we regard as out

of order in practice.

1

6. That we refuse to correspond with churches which are out of order in practice, neither take letters from nor grant letters to go to them.

7. That we recommend this action be taken by the churches.

By motion, the messengers voted that the By-Laws of the Orphans Home be printed in the minutes this year.

CHANGE IN TIME OF ANNUAL MEETING OF ASSOCIATION

The matter of change in associational meeting time from three days to two days was brought up, and by vote of the messengers it was decided to have only two days of the Association; namely, Friday and Saturday before the fourth Sunday in October, with the option of meeting Friday night if necessary. By motion, the Memorial Sermon was omitted.

By motion, Article 8 of the Constitution was amended to read: These Associations shall meet annually on Friday at 10:00 o'clock A. M., after the third Sunday in October, and continue two days, the meetings to be held at such places as may be agreed upon by the Association at its annual sitting.

Motion to adjourn to meet with Gateway Baptist Church, Donelson, Tennessee on Friday after the third Sunday in October, 1970.

BY-LAWS AND RULES OF DECORUM OF THE BAPTIST OLD MINISTERS AND ORPHANS' HOME, LAFAYETTE, TENNESSEE

Article 1.—Object and purpose.

Section 1. The object of this Institution is to care for and support aged ministers, ministers' wives, dependent widows of ministers, and orphan and half orphan children. To effect this benevolent design the management of this Institution shall accept donations and shall hold and administer property thus acquired according to the expressed wish of the donors, when such wishes are not inconsistent of the regulations of the Institution. When no specific wish is expressed by the donors, the funds and property given shall be held and administered according to the regulations of the Home. Donations and bequeaths with the view of becoming permanent investments shall be securely guarded, and shall be used only for such purposes as may be indicated by the donor.

Section 2. Orphan children of either sex of the white race may be admitted into this Institution, and shall be retained, not only with the view of giving them comfortable support, but further, of according them such literary, industrial, vocational and Christian training as will fit them for self support and good citizenship.

Article 2.—Reception of children, aged ministers, ministers' wives and widows of ministers.

Section 1. It shall be the policy of the Home to receive destitute children when orphans or half orphans.

Section 2. The religious faith of parentage of children applying for admission into the Home shall not be considered as a bar to their admission into this Institution.

Section 3. No child abnormal in body or mind shall be admitted into the Home as an inmate.

Section 4. No child shall be brought to the Home until after due notice that the application has been accepted, has been received by those in charge of such a child. All children approved by the management of the Home, to enter the Home, must be delivered to the Home free of cost to the Institution.

Section 5. No child over fourteen years of age will be received into the Home, and those under two years old will be left to the discretion of the Superintendent and Matron.

Section 6. No child shall be received into the Home except by legal consignment, acknowledged before a notary public by the legal custodian of the child, and in all regular instances the application for admission into Home must be indorsed by a Missionary Baptist Church that will certify personal knowledge of conditions and worthiness of the applicant, except when applicant is known personally to the management of the Home.

Section 7. Such destitute, ordained ministers, ministers' wives or widows who are not abnormal in body or mind, as are properly recommended by a Missionary Baptist Church, or personally known by the management to be worthy applicants, may be received into the Home.

Article 3.—Children going out of the Home.

Section 1. Eighteen years shall be the age limit to the residence of a child in the Home. It shall be the policy of the Home to keep in touch with, and to advise and assist in all helpful ways,

those who go out from the Institution to seek a higher education or to enter business. No child shall be dismissed from the Home at the age limit until some definite place of abode and work is secured.

Section 2. It shall be the practice of the Home not to engage in the practice of having children adopted, but to keep them in the Home until they are able to provide a livelihood for themselves.

Article 4.—Board of Managers.

Section 1. The Managers shall consist of nine Trustees.

Section 2. The Trustees shall be chosen from the various churches composing the Southwestern District Baptist Association, Enon Baptist Association and Wiseman Baptist Association, and shall serve indefinitely.

Section 3. The Board of Trustees must always consist of members who are SOUND and FAITHFUL supporters of the TRUE Doctrine and practice of the Direct Missionary Baptists.

Section 4. Should a vacancy occur in the Board of Trustees, the remaining Trustees may select a member to fill such vacancy.

Article 5.-Meetings, Quorum.

Section 1. The meetings of the Board of Trustees shall be annual, special and called. The first Thursday in November shall be a permanent, fixed date for the annual stated meeting of the Trustees.

Section 2. Special meetings shall be held at the place and at the time agreed upon by the Chairman, and six members shall constitute a Quorum. It shall require a majority of the Board of Trustees to constitute a quorum for the purpose of the purchase or the selling of property.

Section 3. The Chairman of the Board of Managers may call a meeting at any time as necessity may demand, and six shall constitute a quorum, such meetings to be at any place convenient.

Article 6.—Election of Officers.

Section 1. The Board of Trustees shall annually elect from their number a Chairman, a Vice-Chairman, a Secretary, an Assistant-Secretary, and also a Superintendent, but who is not required to be one of their number. When agreeable with the Trustees, and the Superintendent, the Superintendent shall be the Treasurer of the Home also. The wife of the Superintendent shall be the Matron of the Home. In case of death or resignation on the part of any one of the Trustees, a successor to fill such a vacancy shall be selected by the remaining Trustees. Should any member of the Board of Trustees become disloyal or prove to be unsound in the faith, the remaining members shall call for his resignation, and if necessary they may declare his place vacant by a majority vote of the remaining members and select his successor immediately.

Section 2. Should either the Superintendent or the Matron become disloyal to the regulations of the Home, or should they prove to be untrue to the faith of Direct Missionary Baptists, it shall be the duty of the Board of Trustees to call for their resignation and if necessary they may declare their place vacant by a majority vote of the Trustees, and select their successors immediately.

Article 7.-The Chairman.

Section 1. It shall be the duty of the Chairman to attend and preside at all meetings of the Board of Trustees, and perform all other such duties as his office requires. In the absence of the Chairman, the Vice-Chairman shall perform all the duties of the Chairman.

man. The Chairman or the Vice-Chairman shall give notice of all meetings.

Article 8.—The Secretary.

Section 1. The Secretary shall keep in a well-bound volume a correct record of all the proceedings of the Board of Trustees He shall preserve all papers committed to his charge. At the termination of his office, he shall deliver to his successor all books, records, and papers pertaining to his office. In the absence of the Section of retary, the Assistant Secretary shall perform all the duties of the Secretary.

Article 9.—The Treasurer. Section 1. The Treasurer, who may or who may not be the Superintendent, shall keep a full and complete record of all properties, such as deeds, evidences of debt, and moneys belonging to the Institution. He shall keep in a well-bound volume accurate and detailed accounts of all moneys and property received by him and of his disbursements and investments, and at each annual meeting, and oftener, if required, make a detailed report of his transactions. He shall report to the Board of Trustees at each meeting the aggregations and itemized his of his disbursements since the previous gate receipts and itemized list of his disbursements since the previous meeting of the Board of Trustees. His books shall be audited at least once a year. The condition of the bond shall be for the honest and faithful discharge of his office.

Section 2. All money, or property, belonging to the Institution, and in the custody of the Treasurer, may be kept by him in such bank or banks as the Board of Trustees may designate. At the close of his term he shall turn over to his successor all books and records pertaining to his office, and all money, other property, deeds, etc., belonging to the Institution.

Article 10.—The Superintendent.

Section 1. The Old Ministers and Orphans' Home shall be under the supervision and management of a general officer to be called the Superintendent of the Home.

Section 2. He shall reside at or in close proximity to the Home as the Trustees may provide.

Section 3. He shall have charge of all buildings, furniture and other such property belonging to the Institution, and shall use care and diligence in preserving the same from injury or loss. He shall, with the Trustees, have charge of the construction of all improvements directed to be made.

Section 4. He shall, with the approval of the Trustees, have power to select and appoint all necessary employees of the Institution, and to prescribe their duties, and to dismiss the same for valid cause, provided no office shall be created by him.

Section 5. He may, with the concurrence of the Trustees, receive into the Institution such applicants as the regulations embrace within the scope of its benefactions.

Section 6. He shall, as far as practical, keep a correct record of the names, ages, parentage, etc., of the inmates received into the Home and the localities from which they come and the day of their admission and removal.

Section 7. As it is the design of this Institution to provide, for those who come under its care, a plan and substantial main-tenance under conditions favorable to their health and happiness and the growth of children, it shall be the duty of the Superintendent to observe such watchful supervision over their diet, clothing, exercise, and the general sanitary needs of the Institution as may be necessary to these ends.

Section 8. As it is the object of this Institution to afford all the influence and impress of a Christian home, the Superintendent will be expected to observe and maintain such regulations and standards in the daily life of the household as will be most conducive to these ends. Regularity, promptness, and system in the daily life of the inmates should be prime requisites, and respect for authority, obedience to regulations, reverence for character and for sacred institutions of all kinds, should be enjoined and make all-persuasive principles of the Institution. It shall be the duty of the Superintendent to afford the inmates the best religious privileges, and as far as possible to lead the children to become Christians, and in a general way teach them the Bible.

Section 9. As it is the object of this Institution to send forth such children as may be committed to its care, prepared for self-support and independence in life, and to become useful members of society, it shall be the aim and endeavor of the Superintendent that they may be taught in the elementary branches of literature and to see that the children are trained to various arts of industry, as their ages, capacities, and facilities provided by the cooperation of the Trustees, may justify.

Section 10. He shall report from time to time to the Trustees as to the conditions and needs of the Home, and shall encourage such cooperation and assistance in the responsible duties of his office as they may be able to give. At the close of each associational year he shall submit a general report in writing, which shall be laid before the Trustees, and read at the Southwestern District Baptist Association, the Enon Baptist Association and the Wiseman Baptist Association.

Article 11.—Religious Faith of Employees.

Section 1. The Superintendent, all matrons, housekeepers, teachers and other administrative employees of the Home must be members, in good standing, of Missionary Baptist Churches of the Direct Missionary Baptist faith.

Article 12.-Amendments.

Section 1. No amendments to the above By-Laws that shall have a tendency to deviate from the faith and practice of Direct Missionary Baptist, shall ever be made by any group including the messengers of the Southwestern District Baptist Association, the Enon Baptist Association and the Wiseman Baptist Association.

The above By-Laws and Rules of Decorum were adopted by the Board of Trustees in regular meeting, which was held October 12, 1950, at the Masonic Building in Nashville, Tenn. Those present were: F. L. Jordan, R. R. Hastings, J. E. McDonald, W. T. Russell, Calvin Gregory and W. R. Overton.

CONSTITUTION

Article I. This body shall be known as Wiseman Association.

Article II. These Associations shall be composed of members duly chosen by regular and orderly Missionary Baptist Churches within our bounds.

Article III. The letters from the churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated, and dead, since last annual meeting.

Artile IV. Each Church shall be entitled to three messengers.

Article V. These Associations shall elect annually as officers, a Moderator, Clerk and Treasurer, whose duties shall be to serve their brethren in their several capacities.

Article VI. These Associations shall never interfere with the independence of any Church, or claim any ecclesiastical power or rights of supervision over any of the Churches.

Article VII. It shall be the object of these Associations to promote the union of the faith of the Gospel with our educational and mission interests.

Article VIII. These Associations shall meet annually on Friday at 10 o'clock A. M., after the third Sunday in October, and continue two days, the meetings to be held at such places as may be agreed upon by the Association at its annual sitting.

Article IX. A majority of the members of any regular meeting shall constitute a quorum for the transaction of business.

Article X. It is expected that these meetings will be missionary n practice as well as theory.

Aricle XI. New churches may be admitted into the Association, who shall petition by letter and messengers, and on examinaiton, if found orthodox and orderly, may be received and made known by the Moderator giving the right hand of fellowship to the Messenger or Messengers present.

Article XII. The Association may exclude from the union any Church or Churches that are heterodox in principle or disorderly in practice.

Article XIII. No proceedings shall be had against any Church except on charges preferred by a sister Church, which shall first have followed the direction of Matthew 18:15, in attempting to bring it to repentance.

Article XIV. The Association at its sitting may admit any visiting brethren present, to sit with them, who shall have liberty to discuss any question and give their views but not to vote except upon subjects of general union.

Article XV. Any alteration may be made to this Constitution at any regular meeting, by a majortiy vote of the members present.

Article XVI. That all questions arising before this Association be decided by a majority vote of the messengers present, except in the reception of churches into our fellowship, and that such reception be by a unanimous vote of messengers present.

ABSTRACTS OF PRINCIPLES OF WISEMAN ASSOCIATION OF BAPTISTS

We, the Missionary Baptists of Christ, being regularly baptized upon the profession of our faith in Christ, are convinced of the necessity of a combination of the churches in order to maintain the general union and communion among ourselves; and being covinced that there can be no communion without union, we think it our duty to set forth in a concise manner the grounds upon which we propose to maintain this union.

- 1. We believe in one true and living God, the Father, the Son and the Holy Spirit.
- 2. We believe that the Scriptures of the Old and New Testaments are the word of God, and that they are the only rule of faith.
- 3. We believe in the doctrine of election, according to the foreknowledge of God, through sanctification of the Spirit unto obedience and sprinkling of the blood of Jesus Christ.
- 4. We believe in the doctrine of original sin and in man's impotency to recover himself from the fallen state he is in by nature of his own free will and ability.
- 5. We believe that sinners are justified in the sight of God by the imputed righteousness of Jesus Christ.
- 6. We believe in the final preservation of the saints, that they will never finally fall away and be lost, and that good works are fruits of faith and follow after justification.
- 7. We believe that baptism and the Lord's Supper are ordinances of Christ, and that they were given to the Church by Him; and that true believers are the only proper subjects for baptism, and that baptism is an immersion, and that orderly members of the Churches of Christ, only, have a right to the Lord's Supper.
- 8. We believe that no minister has a right to administer the ordinances except such as are regularly baptized and come under the hands of the Presbytery.
- 9. We believe in the resurrection of the dead and a general judgment, and that the joys of the righteous and the punishment of the wicked will be eternal.
