Introductory sermon by Elder H. D. Linville

RULES OF DECORUM

- 1. The Association shall be opened and closed with prayer.
- 2. A Moderator and a clerk shall be chosen by the members present.
- 3. Only one person shall speak at a time, who shall arise and address the Moderator by the appellation of Brother Moderator, and shall, while speaking, confine himself to the subject under discusion and shall not be interrupted unless he digress from the subject; and shall in no wise reflect on any other speaker, so as to make remarks on his slips, failing or imperfections, but shall fairly state his views without sophistry or criticism.
- 4. No member shall absent himself from the Association without leave of the Moderator.
- 5. No member shall speak more than three times on the same subject without leave of the body. The chairman on each subject shall have an opening speech of ten minutes and two other speeches of five minutes each.
- 6. Each motion and second shall come under the immediate consideration of the Association, unless withdrawn by the one who made it.
- 7. No member shall whisper, laugh or read any book or paper while the Association is in session.
- 8. No member shall address another by any appellation other than that of Brother.
- 9. On the second day it shall be the duty of the Clerk to read the Rules of Decorum and call the roll of members.
- 10. The Moderator shall be entitled to the same privilege of speaking as any other member, providing the chair be filled, but shall have no vote unless the Association be equally divided.
- 11. Any member violating these rules, or at any time manifesting a spirit contrary to the Gospel shall be reproved or such other course taken with him as the Moderator may think proper, either at his own option or the intimation of any other member.

PROCEEDINGS FIRST DAY, FRIDAY, OCTOBER 25, 1975

At 10:00 A. M., on the above date, Wiseman Baptist Association met in its eighty-third session with Liberty Hill Missionary Baptist Church, Bethpage, Tennessee.

Services were opened with singing, "The Sweetest Song I Know" and "What A Day That Will Be," led by Eld. J. W. Briley. After some remarks and references of respect to our older brethren who have gone on to be with God, whose works still follow them, the Moderator read Hebrews 12:1-3, and called on Eld. Charles R. Moore, who led the body in prayer.

After a very humble and able prayer, the song "Alone In The Garden" was sung, and the Moderator expressed appreciation for the invitation of Liberty Hill church to entertain the Association this year. He then presented Eld. Harold Dean Linville, the appointee of a year ago, to preach the Introductory Sermon.

Brother Linville, after some appropriate remarks, read for a lesson the entire fourth chapter of Hebrews, and chose 2 Corinthians 8:9 for a text, "For ye know the grace of our Lord Jesus Christ, that, though he was rich, yet for your sakes he became poor, that ye through hispoverty might be rich."

Our brother pointed out the sacrifices that Jesus made of all his riches and, in addition, giving his life. He asked the question, Why? The answer, There was a need, because man had sinned and was separated from God. It was shown that out of God's foreknowledge and his love for man, that Jesus stood as a slain lamb from the foundation of the world to redeem man from sin. In Isaish, chapters 7 and 9, he showed the prophesy of His coming and his name. The disobedience of man was offset by the obedience of Christ, by and through which we are a rich people by faith in Him. It was shown that in Christ and Him alone can one have the forgiveness of sins and possess eternal life. He showed where many are turning to something else, departing from the faith and giving heed to seducing spirits and doctrines of devils. Brother Linville showed that the wicked and unbelieving wanted him out of the way, saying "Crucify Him". The world still wants him out of the way. He showed the riches of a born-again child of God to be an heir of God and a joint heir with Christ, he has Jesus as advocate and propituation for sin. He is kept by the power of God, through faith, unto salvation upon the merits of Jesus Christ.

The sermon was well received with many hearty amens, and amid tears and shouts of joy God's people gave to him their hands in token of their appreciation as well as endorsement of that which they had heard, while the songs, "Amazing Grace," "Victory In Jesus," and "This World Is Not My Home" were sung.

At this time, the letters from the various churches were filed with the Clerk, and Elders Howard G. Taylor and H. C. Vanderpool were asked to serve as Reading Clerks. After the reading of all the letters, a motion carried to adjourn one hour for dinner. After announcements, the benediction was offered by Brother Turner Smith, of Polk County Association, Polk County, Missouri.

FRIDAY AFTERNOON

After an abundant and delicious dinner which was evidently enjoyed by everyone, services were resumed with singing "Where We'll Never Grow Old", followed with prayer by Brother Wilburn Foster.

Permanent organization was effected by electing Eld. F. L. Ray, Moderator; Eld. Howard G. Taylor, Assistant Moderator; Eld. W. T. Russell, Clerk; Eld. H. D. Linville, Assistant Clerk; Eld. A. G. Gregory, Treasurer; Eld. Jas. (Pete) Porter, Assistant Treasurer.

Speeches were made by the elected officers, at which time Eld. W. T. Russell who, with this session, has served the Association as Clerk for the past twenty-two years, announced that this would be the last year he could serve as he was moving his membership to Fairview Memorial Baptist Church in Bowling Green, Kentucky, where he is serving as pastor. Fairview Memorial Church represents in Siloam Baptist Association.

At this time, and before Petitionary Letters were presented, it was suggested by W. T. Russell, and a motion carried unanimously, to amend the sixteenth Article of the Constitution, with respect to the reception of churches into our fellowship, from reception by a unanimous vote to a two-thirds majority vote.

Petitionary Letters were called for and Lafayette Missionary Baptist Church, Lafayette, Tennessee and Old Paths Missionary Baptist Church, Lebanon, Tennessee, were received into the body. The hand of fellowship was extended the messengers by the Moderator.

NEXT MEETING PLACE AND PREACHERS OF ANNUAL SERMONS

Rock Bridge, Grace and New Bethel churches asked that the Association meet with them in 1975. Speeches were made by representatives of each church. The vote was then taken, resulting in: Rock Bridge Church being the next meeting place; Introductory Sermon, Eld. Harold Dean Linville; Eld. Hilman Duncan, Alternate; Doctrinal Sermon, Eld. Howard G. Taylor; Eld. H. C. Vanderpool, Alternate.

The report was adopted as read.

The Report on Missions was read by Eld. Burton Massey as follows:

MISSIONS

We, your committee, submit the following on Missions: Realizing the responsibility of preaching the gospel in our area and others, we urge our churches to help our ministers to take advantage of every opportunity to preach the gospel in destitute places and going where they feel God leads them to go in the spread of the gospel. We also urge the churches to support them with their prayers and finances.

One of the great subjects of the bible is Missions. The first Baptist that ever lived was sent from God on a special mission. This man's duty was to preach the gospel of Christ, that men should repent and trust in the Lord and Saviour Jesus Christ.

We find another missionary whose name was Paul preaching the same thing. 2 Cor. 4:3,4. Paul taught that the gospel is hid from the lost and must be revealed to them, through the Spirit, by the preaching of the gospel in power. "But if our gospel be hid, it is hid to them that are lost. In whom the God of this world hath blinded the minds of them which believe not, lest the light of the glorious gospel of Christ, who is the image of God, should shine unto them." If those whom God has called into the ministry do not go forth discharging their duty and fulfill their calling how can the blind ever be able to see the light and come out of darkness and be saved? Jesus said, "Follow me, and I will make you fishers of men." Matt. 4:19

We believe that the great commission of Matthew 28:19, 20 was given to the church to go into all the world and preach the gospel. It was given by the Lord himself to the church which he established during his personal ministry out of material prepared by John the Baptist. We know that we have the truth, and are the ones that was commissioned to carry the gospel to the world. Therefore, let us be willing to go and labor and pray the Lord to send more laborers into the harvest that lost souls, now in darkness, may hear the gospel and turn to the Lord for life and salvation.

Our forefathers were mission-minded and believed in carrying out the commission given to the church. As a result, we have the church today and a pure gospel to preach to the world. So we, as Missionary Baptist need to wake up and start doing more mission work than we have in the past.

The Report on Christian and Ministerial Education, Sunday Schools and Prayer Meetings was read by Eld. Kenneth Woodall as follows:

CHRISTIAN AND MINISTERIAL EDUCATION SUNDAY SCHOOLS, AND PRAYER MEETINGS

We, your committee, submit the following Report:

In chapter two and verse fifteen of the second letter to Timothy the command was given in these words, "Study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." In chapter four and verse two of the same letter, the command

is given to "Preach the word; be instant in season, out of season; reprove, rebuke, exhort with all longsuffering and doctrine." Christ tells us in the world-wide commission, Matt. 28:20, "teaching them to observe all things whatsoever I have commanded you; and, lo, I am with you always, even unto the end of the world. Amen."

By these scriptures, we can easily understand that we as Christians and especially we as ministers are under obligation to God to prepare ourselves in his word for the work which he has left his church to carry on. We are commanded by the apostle Peter to add to our faith virtue, and to virtue knowledge. That knowledge is acquired by the way one applies himself to the study of God's word. God gives wisdom to those that will ask but expects us to grow in grace and the knowledge of His word.

A willingness to be taught is a good step in the preparation of one's work. Bible Schools, Bible Studies and Sunday Schools present some opportunities which should be taken advantage of. The success and enlightenment of our churches depend on how well prepared the man is that occupies the pulpit. David tells us in Psalms 1:1-3, "Blessed is the man that walketh not in the counsel of the ungodly, nor standeth in the way of sinners, nor sitteth in the seat of the scornful. But his delight is in the law of the Lord; and in his law doth he meditate day and night. And he shall be like a tree planted by the rivers of water, that bringest forth his fruit in his season; his leaf also shall not wither; and whatsoever he doeth shall prosper."

Once again, we urge a good sound Sunday School; one which is run by the authority of the church for the purpose of studying God's word and teaching our children the fear of the Lord. As we educate ourselves, we learn more of the will of the Lord and thereby grow in grace and in the knowledge of Him. In this we are made to realize the need of prayer and of being a prayerful people. Christ prayed for us and teaches us to pray for all men. At his house, we should have prayer regularly. May we never forget the value of the prayer of a righteous man. God said it availeth much. James 5:16

SECOND DAY SATURDAY, OCTOBER 26, 1974

Services were opened with singing, "He Had To Go To Calvary", under the direction of Brother Clyde Dillaha. The Moderator read from 1 John 3:1, 2. Prayer was offered by Eld. Hilman Duncan, followed by the song, "I Want My Lord To Be Satisfied With Me."

The Clerk was asked to read the Rules of Decorum and call the roll of messengers. A quorum being present, the minutes of the first day were read and adopted.

The regular order of business was taken up, and the Report on Faith and Practice of a True Baptist Church was read by Eld. H. C. Vanderpool as follows:

FAITH AND PRACTICE OF A TRUE BAPTIST CHURCH

We, your committee, submit the following report on the above subject:

When we speak of "True Baptists," we use these words to distinguish us from those who no longer believe the truth nor practice that which is acceptable to God, but yet, in one form or another wear the name Baptist.

We must at the same time realize that the church organized by Jesus during his personal ministry was called in the scriptures by the head and founder, "my church" Matt. 16:18. Later at Antioch, we find the members called "Christians". As time passed and much persecution came upon the true churches of the Lord, various names were given them by their enemies, usually after the leaders of the churches.

So we find the names in the Bible and on the pages of history; My church, the church, Christians, Donatists, Arnoldists, Albigenses, Henricians, Petro-Brussins, Waldenses, Ana-Baptists, Particular Baptists, Regular Baptists, Separate Baptists, United Baptists, and then a little over a hundred years ago, the name Missionary came into use, and today we usually refer to ourselves as Missionary Baptists or

as True Baptists.

- So, True Baptists, their faith and practice has been found somewhere in the world since the days of Christ and the Apostles. Not by the same name in all centuries, but in all centuries by the same doctrine and practice.
- 1. TRUE BAPTISTS BELIEVE THE BIBLE TO BE THE INSPIRED WORD OF GOD 2 Tim. 3:16,17; 2 Sam. 23:1,2; Acts 1:15,16; Acts 3:18-21; Luke 24:27-44.
- 2. TRUE BAPTIST BELIEVE IN ONE TRUE AND LIVING GOD. THAT IN THE UNITY OF THE GODHEAD THERE ARE THREE PERSONS, THE FATHER, THE SON AND THE HOLY SPIRIT, THAT THEY ARE EQUAL IN EVERY DIVINE PERFECTION AND ARE EXECUTING DISTINCT BUT HARMONIOUS OFFICES IN THE GREAT WORK OF REDEMPTION. Matt. 28:19; Phil. 2:5,6; John 10:30; Rev. 4:11; Jere. 10:10; John 4:24; Psalms 83:18; I Cor. 2:10,11; Acts 5:3,4; John 14:23-26; 2 Cor. 13:14.
- 3. TRUE BAPTIST BELIEVE THE FIRST MAN ADAM WAS CREATED HOLY, BUT BY VOLUNTARY TRANS-GRESSION FELL FROM THAT HOLY STATE AND IN CONSEQUENCE OF HIS DEED BROUGHT SIN AND DEATH TO THE ENTIRE HUMAN RACE. Gen. 1:26,27; Rom. 5:12; Job 14:1-4; Psalm 51:1; Isaish 53:6
- 4. TRUE BAPTIST BELIEVE SINNERS ARE SAVED BY THE GRACE OF GOD AND THAT WITHOUT A MIXTURE OF WORKS. THAT THIS FREE SALVATION IS PROVIDED THROUGH THE MEDIATORIAL OFFICES OF THE SON OF GOD. THAT CHRIST CAME INTO THE WORLD, DIED ON THE CROSS OF CALVARY, SHED HIS BLOOD FOR EVERY MAN. Eph. 2:8,9; Rom. 3:20-26; I Cor. 15:9,10; John 3:16; Heb. 2:9; John 1:11-13; 2 Pet. 3:9; Acts 17:30; Phil. 2:5-8.
- 5. TRUE BAPTIST BELIEVE THE SINNER MUST HEAR THE GOSEPL, BELIEVE IT TO BE THE TRUTH, BE SO CONVINCED BY IT THAT A GODLY SORROW SETS UP IN THE HEART (THE SOUL OR THE INNER MAN) TO THE EXTENT THAT THE PERSON CAN REPENT OF SIN TO GOD AND EXERCISE FAITH IN CHRIST WITH ALL THE HEART, AND AT THAT TIME SALVATION COMES TO THE SOUL, THAT ALL SINS ARE FORGIVEN, THAT THE SOUL HAS THE SPIRITUAL NATURE OF GOD AND IS A

NEW CREATURE IN CHRIST JESUS. Rom. 10:10-17; Luke 13:3; John 3:16; Acts 2:22-41; I Pet. 1:9; 2 Cor. 5:17; Rom. 1:16; John 5:24; Rom. 8:1.

- 6. TRUE BAPTIST BELIEVE THAT WHEN A SINNER HAS BEEN SAVED AS MENTIONED IN POINT ABOVE, HE IS SECURED IN CHRIST FOR ALL TIME AND ETERNITY. THAT AS WE ARE NOT SAVED BY WORKS, BUT BY THE GRACE OF GOD, neither are we kept by works. THAT AT THE TIME ONE IS BORN AGAIN, BORN OF GOD, HIS NAME IS RECORDED IN THE LAMB'S BOOK OF LIFE WHERE IT SHALL ETERNALLY BE. John 5:24; John 10:27,28; Rom. 8:35-39; I John 3:9; I Pet. 1:3-5; Psalm 89:20-37 and 37:28.
- . 7. TRUE BAPTIST BELIEVE GOD'S PEOPLE SHOULD LIVE DEVOTED LIVES. THAT EVERY EFFORT SHOULD BE MADE TO SO LIVE AND LET THEIR LIGHT SHINE THAT MEN WOULD SEE THEIR GOOD WORKS AND GLORIFY GOD IN HEAVEN. THEY BELIEVE THAT GOD REWARDS SUCH LIVES AND WORK, AND THAT HE CHASTISES HIS CHILDREN FOR THEIR SINS AND ERRORS. I Cor. 3:6-15; Matt. 5:13-16; Heb. 12:6-11; Ecc. 12:13,14; Rev. 22:12.
- 8. TRUE BAPTIST BELIEVE THAT EACH BAPTIST CHURCH IS AN INDEPENDENT BODY AND NO CHURCH CAN EXERCISE AUTHORITY OVER ANOTHER. HOWEVER, THEY CAN FELLOWSHIP AND PROMOTE THE GENERAL WELFARE AND WORK OF THE KINGDOM IN ASSOCIATIONAL CAPACITY AND OTHER UNITED EFFORTS. I Cor. 1:2; Rom. 16:1; and 3-5; Gal. 1:2; Phil. 1:1; Col. 1:2; Col. 4:15; I Thess. 1:1; Rev. 1:11.
- 9. TRUE BAPTIST BELIEVE THERE ARE TWO ORDINANCES OF THE CHURCH, BAPTISM AND THE LORD'S SUPPER. THAT ONLY SAVED PEOPLE, BORN AGAIN, THOSE POSSESSING THE HOLY SPIRIT ARE SCRIPTURAL SUBJECTS FOR BAPTISM. Matt. 3:1-9; Acts 2:41; Acts 8:26-39; Acts 10:44-48; Acts 16:25-34.

The Report on Temperance, Morality and Church Discipline was read by Eld. Everett Scruggs as follows:

TEMPERANCE, MORTALITY AND CHURCH DISCIPLINE

In I Cor. 9:25 Paul talks about being temperate in all things. That should be applied in eating, drinking, passion, and also Church Discipline.

Solomon said that whosoever is deceived by strong drink is not wise. Pro. 20:1. Also see Pro. 23:19-21 "Hear thou, my son, be wise, and guide thine heart in the way. Be not among winebidders; among riotous eaters of flesh; For the drunkard and the glutton shall come to poverty: and drowsiness shall clothe a man with rags." In Gal. 5:23 we learn that temperance is a fruit of the Spirit.

The works of the flesh are adultery, fornication, uncleanness, lascivousness, idolatry, witchcraft, hatred, variance, emulations, wrath, strife, seditions, heresies, envying, murders, drunkenness, revelling, and such like. Paul was writing this to the church of Galatia and said, They which do such things shall not inherit the Kingdom of God. Gal. 5:19-21. This sounds like what the church doesn't take out God will.

Paul, in Titus 2:11, 12 tells us that the grace of God teaches us that denying ungodliness and worldly lust, we should live soberly, righteously and godly, in this present world.

Paul said again in Gal. 6:1 "Brethren, if a man be overtaken in a fault, ye which are spiritual, restore such an one in the spirit of meekness; considering thyself, lest thou also be tempted." After this reasoning in meekness the commandment is given in ¹ I Thess. 3:6, "Withdraw yourselves from those that walk disorderly."

Jesus said in Matt. 18 to forgive a brother not seven times but seventy times seven. Discipline is about out of style today. There are some exclusions, and some without a chance to make acknowledgements.

The time having arrived for the preaching of the Doctrinal Sermon, the Moderator called for a song, and "Kneel At The Cross" was sung, after which he presented Eld. W. T. Russell to preach the sermon.

Brother Russell took the stand, and after expressing his appreciation for the opportunity of standing before the Association for the twenty-first time to preach the Doctrinal Sermon, he read for a lesson Eph. 4 and chose for a text the thirteenth verse, "Till we all come in the unity of the faith, and of the knowledge of the Son of God, unto a perfect man,

unto the measure of the stature of the fulness of Christ:" He used for a Subject, The Lord's Church, God's purpose for it in the world, and how, through instruction, the knowledge of Christ and unity of the faith.

He pointed out how Adam must have instructed his sons concerning God's promise of a Saviour, as well as how God clothed them with the skins of slain beasts, the shedding of blood and the righteousness of Christ. Abraham was instructed of God and followed him by faith, and later gave him a son, in whom the seed of Abraham was called, and that seed was Christ

God used Moses and the law as a schoolmaster to instruct Israel concerning Christ, by whom grace and truth came. The cremonial law served as a source of instruction.

God sent John the Baptist to instruct the people concerning Christ, and when the fulness of time was come God sent His Son, the great teacher. John baptized those who were instructed, repented and believed on Christ. Jesus called them out (set up his church) and taught his disciples. He gave the church gifts, apostles, prophets, teachers, etc., for the work of the ministry and the edifying of the body of Christ. The church was commissioned to go teach all nations, baptizing them and teaching them the observance of all He has commanded.

Brother Russell preached with power and ability. His sermon was well received, and while singing "Amazing Grace" and other, the congregation gave him their hand of endorsement.

A motion carried to adjourn one hour for dinner. The benediction was offered by Brother George Taylor.

SATURDAY AFTERNOON

A very enjoyable and well prepared dinner which was plentious was enjoyed by the entire congregation, and at the stated time services were resumed with singing, "Jesus Use Me", led by Eld. Thomas Shoemake. Prayer was offered by Eld. Burton Massey, and after the singing of "Does Jesus Care", the Moderator welcomed all visitors in our midst.

The Report on State of Religion was read by Eld. J. W. Briley as follows:

STATE OF RELIGION AND HINDRANCES TO GOD'S CAUSE

Religion, (1) The service and adoration of God as expressed in forms of worship. (2) The profession or practice of religious beliefs. We see by these definitions given there is true religion and false religions. So in keeping with our subject, we see the state, condition, situation and status of false religions growing at an alarming rate, not only in our immediate area but the world over. There are some false religions declining, but where there is a decline in one section, there springs up a new cult in other sections in which the unlearned flock to. Man is prone to worship.

True or pure religious worship is on the decline in almost all places I have any knowledge of. Paul warned us about this very thing in II Tim. 3-5 "Having a form of godliness, but denying the power thereof: from such turn away." Also II Tim. 4-3,4 "For the time will come when they will not endure sound doctrine; but after their own lusts shall they heap to themselves teachers, having itching ears; and they shall turn away their ears from the truth, and shall be turned unto fables."

When man's ways are substituted for God's Word and doctrine, history always records a decline in religion. Let each one of us take inventory of ourselves and ask ourselves, What can I do by the help of God to upgrade the state of religion? Preachers, prepare ourselves better by applying ourselves to the study of God's word prayerfully, asking God for wisdom, James 1-5 "If any of you lack wisdom, let him ask of God, that giveth to all men liberally, and upbraided not and it shall be given him." Sunday School teachers, prepare for the task of teaching His word. Deacons, Lay-members and all who name the name of Christ, study God's Word and put it into practice. The state of religion will rapidly improve if these admonitions are carried out.

Hinderances to God's Cause - Hinder (1) To keep back or behind, check, obstruct. (2) To prevent; embarrass, hinder, obstruct, block and to put obstacles in the way of one in action, I Thess. 2-18 "Wherefore we would have come unto you, even I Paul, once and again; but Satan hindered us."

The devil has been and still is the reason for all the hinderances to the cause of God. He's had almost six

thousand years of experience, beginning with tempting of man in the garden of Eden Gen. 3-1. The great hinderance is God's children walking after the flesh and not after the Spirit: Gal. 5-16.17 "This I say then, Walk in the Spirit, and ve shall not fulfil the lust of the flesh. For the flesh lusteth against the Spirit, and the Spirit against the flesh; and these are contrary the one to the other; so that ve cannot do the things that ye would. Churches using the wrong methods in financing the work of the Lord, such as bake sales and probably many others. (There has been things creeping in our Old Fashion Baptist ranks that is hindering; digressing from the Bible method under the Church and Grace age of supporting the work, such as the tithe system. This is foreign to the new testament churches, so anything such as this is a hindrance because it denies man of his God given right of choice, II Cor. 9-7).

The failing to carry out formitive and corrective church dicipline is a great hinderance to the cause today. David hindered God's cause long ago II Samuel 12-14, so we today have seen the cause hindered by some of the preachers in our day not only they but other men and women who claim to be God's people of which we have no scriptual grounds nor command to keep. These are hinderances today and will cause many more problems in the future. These are of the world. Yes, Christ was born of the Virgin Mary, but we as God's people are to remember his death until he comes. I Cor. 11-26.

The failing to assemble at Gods house, Heb. 10-25 is a great hinderance. We are to set the right patterns, Titus 2-7 in all things. Worship, praying, singing to be in the Spirit John 4-24.

In the face of all our hinderances, if we will earnestly and prayerfully search the scriptures these can be overcome and by these being corrected the state of religion will rapidly improve. Then in many places where the Church has lost respect it can be regained.

May our Heavenly Father help us to take a prayerful look at the whole commission in Matt. 28-19,20.

Heb. 13-5, I will never leave thee, nor forsake thee. If God be for us who can be against us. Brethern and Sisters, let us take new courage. Let us rely on God's promises. The guidance of the Holy Spirit and go marching on to Victory because Victory is in Him who saved us and called us to be soldiers of the cross.

BY-LAWS AND RULES OF DECORUM OF THE BAPTIST OLD MINISTERS AND ORPHANS' HOME, LAFAYETTE, TENNESSEE

Article 1.—Object and purpose.

Section 1. The object of this Institution is to care for and support aged ministers, ministers' wives, dependent widows of ministers, and orphan and half orphan children. To effect this benevolent design the management of this Institution shall accept donations and shall hold and administer property thus acquired according to the expressed wish of the donors, when such wishes are not inconsistent of the regulations of the Institution. When no specific wish a expressed by the donors, the funds and property given shall be held and administered according to the regulations of the Home. Donations and bequeaths with the view of becoming permanent investments shall be securely guarded, and shall be used only for such purposes as may be indicated by the donor.

Section 2. Orphan children of either sex of the white race may be admitted into this Institution, and shall be retained, not only with the view of giving them comfortable support, but further, of according them such literary, industrial, vocational and Christian training as will fit them for self support and good citizenship.

Article 2.—Reception of children, aged ministers, ministers' wives and widows of ministers.

Section 1. It shall be the policy of the Home to receive destitute children when orphans or half orphans.

Section 2. The religious faith of parentage of children applying for admission into the Home shall not be considered as a bar to their admission into this Institution.

Section 3. No child abnormal in body or mind shall be admitted into the Home as an inmate.

Section 4. No child shall be brought to the Home until after due notice that the application has been accepted, has been received by those in charge of such a child. All children approved by the management of the Home, to enter the Home, must be delivered to the Home free of cost to the Institution.

Section 5. No child over fourteen years of age will be received into the Home, and those under two years old will be left to the discretion of the Superintendent and Matron.

Section 6. No child shall be received into the Home except by legal consignment, acknowledged before a notary public by the legal custodian of the child, and in all regular instances the application for admission into Home must be indorsed by a Missionary Baptist Church that will certify personal knowledge of conditions and worthiness of the applicant, except when applicant is known personally to the management of the Home.

Section 7. Such destitute, ordained ministers, ministers' wives or widows who are not abnormal in body or mind, as are properly recommended by a Missionary Baptist Church, or personally known by the management to be worthy applicants, may be received into the Home.

Article 3.—Children going out of the Home.

Section I. Eighteen years shall be the age limit to the residence of a child in the Home. It shall be the policy of the Home to keep in touch with, and to advise and assist in all helpful ways,

those who go out from the Institution to seek a higher education or to enter business. No child shall be dismissed from the Home at the age limit until some definite place of abode and work is secured.

Section 2. It shall be the practice of the Home not to engage in the practice of having children adopted, but to keep them in the Home until they are able to provide a livelihood for themselves.

Article 4.-Board of Managers.

Section 1. The Managers shall consist of nine Trustees.

Section 2. The Trustees shall be chosen from the various churches composing the Southwestern District Baptist Association, Enon Baptist Association and Wiseman Baptist Association, and shall serve indefinitely.

Section 3. The Board of Trustees must always consist of members who are SOUND and FAITHFUL supporters of the TRUE Doctrine and practice of the Direct Missionary Baptists.

Section 4. Should a vacancy occur in the Board of Trustees, the remaining Trustees may select a member to fill such vacancy.

Article 5.-Meetings, Quorum.

Section 1. The meetings of the Board of Trustees shall be annual, special and called. The first Thursday in November shall be a permanent, fixed date for the annual stated meeting of the Trustees.

Section 2. Special meetings shall be held at the place and at the time agreed upon by the Chairman, and six members shall constitute a Quorum. It shall require a majority of the Board of Trustees to constitute a quorum for the purpose of the purchase or the selling of property.

Section 3. The Chairman of the Board of Managers may call a meeting at any time as necessity may demand, and six shall constitute a quorum, such meetings to be at any place convenient.

Article 6.-Election of Officers.

Section 1. The Board of Trustees shall annually elect from their number a Chairman, a Vice-Chairman, a Secretary, an Assistant-Secretary, and also a Superintendent, but who is not required to be one of their number. When agreeable with the Trustees, and the Superintendent, the Superintendent shall be the Treasurer of the Home also. The wife of the Superintendent shall be the Matron of the Home. In case of death or resignation on the part of any one of the Trustees, a successor to fill such a vacancy shall be selected by the remaining Trustees. Should any member of the Board of Trustees become disloyal or prove to be unsound in the faith, the remaining members shall call for his resignation, and if necessary they may declare his place vacant by a majority vote of the remaining members and select his successor immediately.

Section 2. Should either the Superintendent or the Matron become disloyal to the regulations of the Home, or should they prove to be untrue to the faith of Direct Missionary Baptists, it shall be the duty of the Board of Trustees to call for their resignation and if necessary they may declare their place vacant by a majority vote of the Trustees, and select their successors immediately.

Article 7.—The Chairman.

Section 1. It shall be the duty of the Chairman to attend and preside at all meetings of the Board of Trustees, and perform all other such duties as his office requires. In the absence of the Chairman, the Vice-Chairman shall perform all the duties of the Chair-

dent to observe such watchful supervision over their diet, clothing, exercise, and the general sanitary needs of the Institution as may be necessary to these ends.

Section 8. As it is the object of this Institution to afford all the influence and impress of a Christian home, the Superintendent will be expected to observe and maintain such regulations and standards in the daily life of the household as will be most conducive to these ends. Regularity, promptness, and system in the daily life of the inmates should be prime requisites, and respect for authority, obedience to regulations, reverence for character and for sacred institutions of all kinds, should be enjoined and make all-persuasive principles of the Institution. It shall be the duty of the Superintendent to afford the inmates the best religious privileges, and as far as possible to lead the children to become Christians, and in a general way teach them the Bible.

Section 9. As it is the object of this Institution to send forth such children as may be committed to its care, prepared for self-support and independence in life, and to become useful members of society, it shall be the aim and endeavor of the Superintendent that they may be taught in the elementary branches of literature and to see that the children are trained to various arts of industry, as their ages, capacities, and facilities provided by the cooperation of the Trustees, may justify.

Section 10. He shall report from time to time to the Trustees as to the conditions and needs of the Home, and shall encourage such cooperation and assistance in the responsible duties of his office as they may be able to give. At the close of each associational year he shall submit a general report in writing, which shall be laid before the Trustees, and read at the Southwestern District Baptist Association, the Enon Baptist Association and the Wiseman Baptist Association.

Article 11.—Religious Faith of Employees.

Section 1. The Superintendent, all matrons, housekeepers, teachers and other administrative employees of the Home must be members, in good standing, of Missionary Baptist Churches of the Direct Missionary Baptist faith.

Article 12.—Amendments.

Section 1. No amendments to the above By-Laws that shall have a tendency to deviate from the faith and practice of Direct Missionary Baptist, shall ever be made by any group including the messengers of the Southwestern District Baptist Association, the Enon Baptist Association and the Wiseman Baptist Association.

The above By-Laws and Rules of Decorum were adopted by the Board of Trustees in regular meeting, which was held October 12, 1950, at the Masonic Building in Nashville, Tenn. Those present were: F. L. Jordan, R. R. Hastings, J. E. McDonald, W. T. Russell, Calvin Gregory and W. R. Overton.

CONSTITUTION

Article I. This body shall be known as Wiseman Association.

Article II. These Associations shall be composed of members duly chosen by regular and orderly Missionary Baptist Churches within our bounds.

Article III. The letters from churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated, and dead, since last annual meeting.

Article IV. Each Church shall be entitled to three messengers. Article V. These Associations shall elect annually as officers, a Moderator, Clerk and Treasurer, whose duties shall be to serve their brethren in their several capacities.

Article VI. These Associations shall never interfere with the independence of any Church, or claim any ecclesiastical power or rights of supervision over any of the Churches.

Article VII. It shall be the object of these Associations to promote the union of the faith of the Gospel with our educational and mission interests.

Article VIII. These Associations shall meet annually on Friday at 10 o'clock A.M., after the third Sunday in October, and continue two days, the meetings to be held at such places as may be agreed upon by the Association at its annual sitting.

Article IX. A majority of the members of any regular meeting shall constitute a quorum for the transaction of business.

Article X. It is expected that these meetings will be missionary in practice as well as theory.

Article XI. New Churches may be admitted into the Association who shall petition by letter and messengers, and on examination, if found orthodox and orderly, may be received and made known by the Moderator giving the right hand of fellowship to the Messenger or Messengers present.

Article $X\Pi$. The Association may exclude from the union any Church or Churches that are heterodox in principle or disorderly in practice.

Article XIII. No proceedings shall be had against any Church except on charges preferred by a Sister Church, which shall first have followed the direction of Matthew 18:15, in attempting to bring it to repentance.

Article XIV. The Association, at its sitting may welcome any visiting brethren present, who shall have liberty to join in the discussion of any report listed in the Order of Business, but shall have no vote in any action of the association.

Article XV. Any alteration may be made to this Constitution at any regular meeting, by a majority vote of the members present. Article XVI. That all questions arising before this Association be decided by a majority vote of the messengers present, except in the reception of churches into our fellowship, and that such reception be by a two-thirds vote of messengers present.
