

RULES OF DECORUM

- 1. The Association shall be opened and closed with prayer.
- 2. A Moderator and a clerk shall be chosen by the members present.
- 3. Only one person shall speak at a time, who shall arise and address the Moderator by the appellation of Brother Moderator, and shall, while speaking, confine himself to the subject under discussion and shall not be interrupted unless he digress from the subject; and shall in no wise reflect on any other speaker, so as to make remarks on his slips, failing or imperfections, but shall fairly state his views without sophistry or criticism.
- 4. No member shall absent himself from the Association without leave of the Moderator.
- 5. No member shall speak more than three times on the same subject without leave of the body. The chairman on each subject shall have an opening speech of ten minutes and two other speeches of five minutes each.
- 6. Each motion and second shall come under the immediate consideration of the Association, unless withdrawn by the one who made it.
- 7. No member shall whisper, laugh or read any book or paper while the Association is in session.
- 8. No member shall address another by any appellation other than that of Brother.
- 9. On the second day it shall be the duty of the Clerk to read the Rules of Decorum and call the roll of members.
- 10. The Moderator shall be entitled to the same privilege of speaking as any other member, providing the chair be filled, but shall have no vote unless the Association be equally divided.
- 11. Any member violating these rules, or at any time manifesting a spirit contrary to the Gospel shall be reproved or such other course taken with him as the Moderator may think proper, either at his own option or the intimation of any other member.

FRIDAY - October 21, 1977

On the above date, Wiseman Baptist Association convened in its 86th annual session with Buffalo Springs Missionary Baptist Church, Sumner County, Tennessee. Services began at 10:00 A. M. with singing. Bro. James A. Thompson led the singing being accompanied at the piano by Bro. Don Xavier Hines. "Holy Manna," was sung followed by preliminary remarks by Elder F. L. Ray, the moderator. He then read for a devotional, II Tim. 4:1-8. Elder Kenneth Massey led in prayer. The congregation then sang, "The Old Country Church On The Hill."

The moderator presented Elder J. W. Briley, the appointee, to preach the Introductory Sermon. After some remarks, Bro. Briley requested that "Amazing Grace," be sung. After the song he read for a lesson, Matt. 28: 16-20. He used for a subject, "Missions."

He spoke of the great commission which Christ gave to the church, which is binding upon true Baptists today as it was on the church at Jerusalem. He used II Peter 3:1-4, to show that we of the present age should be reminded of the obligation and opportunuties of preaching the word of God as was preached by the prophets and apostles and also our Lord and Saviour Jesus Christ. Paul's statement to the church at Corinth, II Cor. 5:20, was read to show we are ambassadors for Christ, with the additional reference to Eph. 6:20; speaking of our responsibility of standing firm for the cause of Christ. That when we are true ambassadors of Christ, we are truly carrying out the command of the Lord to His church through Missions.

Jonah of the Old Testament was referred to as a missionary. He preached to the people of Ninevah, they repented and believed, which pleased God. I John 4:9 was given to prove that through God's love we have eternal life through Christ, and as Missionary Baptists and ambassadors for Christ we should, through missions, preach the gospel of Christ to the whole world. Proof texts given were, I John 2:2; Heb. 2:9.

John the Baptist was mentioned, John 1:6; Matt. 3:1-2. Again missions was emphasized by using Acts 13:1-4. In his closing remarks, Bro. Briley made mention of God-called preachers and our duties and responsibilities to God, to the church and to the world in carrying out the command of the great commission as given to the church at Jerusalem by the Lord. He closed his message with I Cor. 1:23-29 and Phil. 2:2-8. Truly this was a good, sound, scriptural, Baptist sermon. The congregation extended to Bro. Briley and to one another the right hand of fellowship while singing "Send The Light," "What A Fellowship" and "Standing On The Promises."

The church letters were filed with the clerk.

Moved to adjourn one hour for lunch. After announcements, Elder F. W. Lambert prayed the benediction.

FRIDAY AFTERNOON

After an hour of fellowship and a very enjoyable meal, we came together by singing, 'He'll Pilot Me." Bro. Don Xavier Hines played the piano as Bro. Clyde Dilleha led the singing. Moved that the report be adopted, and that pictures and obituaries of the deceased ministers of the Association during the past year be included in the minutes.

The assistant moderator presented Elder F. L. Ray to preach the Memorial Sermon. Bro. Ray made preliminary remarks and read for a lesson II Cor. 5: 1-10. In his introductory remarks, Bro. Ray reported that in the past forty years, Wiseman Baptist Association had lost 1,454 members by death. He expressed his desire to pay tribute of respect to all these.

He spoke of the great heritage that these brethren and sisters had left to us. He used for a text "These all died in faith," Heb. 11:13. Reference was made to a faithful woman, Mark 14:9, when Jesus said, "Wheresoever this gospel shall be preached throughout the whole world, this also that she hath done, shall be spoken of for a memorial of her." Other scriptures given here were Ps. 112:6: Rom. 10:4

Bro. Ray preached that all those of whom he was speaking in memory of, all died in faith, having embraced the doctrine of the Bible and of Baptists when presenting themselves for membership to the respective churches to which they belonged. That the faith which they embraced included the belief that God had only one plan of salvation in all ages, repentance toward God and faith in our Lord Jesus Christ. That they believed Jesus set up his church while here in the world as taught in the scriptures.

Bro. Ray spoke of our swift journey through this life and that we, too, shall soon join all those named in Hebrews 11, and the 1,454 of whom he spoke who had died in the past forty years. In appreciation of this good Memorial Sermon, the congregation extended to Bro. Ray and to one another the right hand of fellowship while singing, "Is It Far?" and "Some Day."

The motion for the adoption of the report on Obituaries carried after the Memorial Sermon and additional talks by others.

Moved to adjourn until 9:00 A.M. on Saturday. Announcements were made and Elder Paul W. Ray prayed the benediction.

SATURDAY, OCTOBER 22, 1977

The chair was filled by the assistant moderator, Elder Howard G. Taylor, while Elder F. L. Ray read the report on Christian and Ministerial Education, Sunday Schools and Prayer Meeting.

CHRISTIAN AND MINISTERIAL EDUCATION, SUNDAY SCHOOLS AND PRAYER MEETINGS

We, your committee, submit the following report:

We really have four subjects in one report. We will try to touch on all of them. Christian Education and Ministerial Education are in demand in these modern times. Old Union Missionary Baptist Church has instituted a school for ministers. The next session will be the last week in March 1978. This School is sound and is under the control of Old Union Baptist Church. We recommend it to all ministers. We trust that some day it will extend its instructions to Sunday School teachers, Deacons and lay members.

The church is the greatest teaching institution in the world. It is the light of the world and the salt of the earth, the pillar and ground of the truth. Most of the churches in this Association reported a Sunday School. All churches have a weekly Prayer Meeting. "Now Peter and John went up together into the temple at the hour of prayer." Acts 3:1. The Lord said, My house is a house of prayer. More teaching, more praying, more attendance and better listening will help our learning.

FAITH AND PRACTICE OF TRUE BAPTISTS

We believe and do preach to the lost, as Paul preached, repentance toward God and faith toward our Lord Jesus Christ. (Acts 20-21) As our Lord also taught that repentance and remission of sin should be preached in his name among all nations beginning at Jerusalem. (Luke 24-47) We believe and practice principles and doctrines which was once delivered to the Saints. (Jude 1-3) We are to be steadfast and unmoveable always abounding in the work of the Lord. (I Cor. 15-58) And remove not the ancient land mark which thy fathers have set. (Proverbs 22:28 – Jeremiah 6:16 – Acts 1:21-22. We suggest the Articles of Faith and The Church Covenant be printed in our minutes. Our people need to read and study them so we can give an answer why'we are True Baptists.

The Report on Temperance, Morality and Church Discipline was read by Elder Hilman Duncan.

TEMPERANCE, MORALITY AND CHURCH DISCIPLINE

TEMPERANCE:

And every man that striveth for the mastery is temperate in all things. (I Cor. 9:25). We are in a race, Heb. 12:1. It has been before us and we are told to be temperate, or to lay aside every weight (all hinderances) and the sin

which does so easily beset us (practice self-control) and run with patience the race.

In any struggle, or contest, we must practice self-discipline to win the crown and to please him who has called us to be a soldier, II Tim. 2:4. If we put forth every effort to win for God our morals will be without reproach.

MORALITY:

The guidelines for morality are found in the word of God. We are living in a time of permissiveness, where everything goes. The word of the Lord is unto them a reproach, they have no delight in it, Jer. 6:10. Our morals have deteriorated until sin doesn't seem sinful anymore. Our morals should be measured by the Bible, and our lives should be above reproach.

CHURCH DISCIPLINE:

We believe it is our duty to pray for each other and to encourage each other. If a man sins a sin that is not unto death, we should pray for him, I John 5:16. But we are taught by the word of God to withdraw ourselves from every brother that walketh disorderly, II Thess. 3:6. Of course this means after we have exhausted all efforts to restore the person to right living. After withdrawing fellowship we are to exhort as a brother. If he acknowledges and makes right his wrong, and comes back to the church, we are to receive him back, lest he be overmuch sorrowed.

Moved that the report be adopted. The time having arrived for the Doctrinal Sermon, the discussion of the report was suspended until after lunch.

The congregation sang, "I Have Found The Way." after which the moderator presented Elder James (Pete) Porter, the appointee, to preach the Doctrinal Sermon. Bro. Porter spoke of Buffalo Springs Church being his first pastorate as a young minister. He made a number of good timely remarks relative to the ministry, opportunities of Baptist ministers of today to attend Bible Schools along with the additional responsibilities of ministers of today. He read for a lesson Heb. 10:1-18, and used for the basis of his message verse 14, "For by one offering he hath perfected for ever them that are sanctified," using the subject "The Security of Believers."

In his introductory scriptures on the subject he presented the Bible truth that mankind is a two-fold being. He referred to the two births, vs. the fleshly birth and the Spiritual birth. Scriptures given here were I John 1:8 and I John 3:9. Matt. 10:28 was given to distinguish the soul from the body.

Bro. Porter brought forth the truth of God's word that the blood of animals never did take away sins, but rather the sins of all ages had been washed away by the blood of Christ, saving us eternally. Jesus told the woman at Jacob's well, "But whosoever drinketh of the water that I shall give him shall never thirst, but the water that I shall give him shall be in him a well of water springing

up into everlasting life." John 4:14. Further words of Jesus quoted were, "Verily, verily, I say unto you, He that heareth my word, and believeth on him that sent me, hath everlasting life, and shall not come into condemnation; but is passed from death unto life." John 5:24.

Additional scriptures given were Rev. 3:5; Psalm 1:1-3; John 10:27-29, showing as the basic scripture text taught, "by one offering we are perfected for ever." Bro. Porter gave Psalm 51:1-2, where David, after sinning, was not lost, but humbly sought forgiveness of sins and the restoration of "not his salvation" but rather, "the joy of salvation."

He spoke of the eternal security which we have as the people of God, by which we shall finally reach our eternal home to live with the Lord forever. To give all honor and glory to God for the saving, securing, and receiving eternally to Himself all the redeemed, is a Bible and true Baptist doctrine. In his closing remarks Bro. Porter made it plain and in a Spiritual and forceful manner that we're rich in the grace of God, and Spiritual possessions. UNFINISHED BUSINESS

In 1976 a Sunday School Literature Committee, composed of five pastors in the Association, was appointed to study the possibility and feasibility of our churches writing, printing and distributing our own Sunday School Literature.

The report by that committee was read by Elder H. C. Vanderpool.

SUNDAY SCHOOL LITERATURE COMMITTEE REPORT

Upon a recommendation to the Wiseman Baptist Association in its annual session in 1976, to appoint a Sunday School Literature Committee, the body voted to accept the recommendation and a committee composed of five pastors in the Association was appointed. They were as follows: Elder A. G. Gregory, Harold D. Linville, Charles R. Moore, Howard G. Taylor and H. C. Vanderpool. The committee was to study the possibility and feasibility of our churches having our own Sunday School Literature written, printed and distributed to all churches desiring to use same.

The said committee held a meeting at Gallatin, Tennesse on January 4, 1977. At that meeting it was unanimously agreed, after much discussion of the matter, that some given church which represents annually in the Wiseman Baptist Association, should sponsor the literature work, that on the same principle of missionary work, Baptist schools, etc. the work would be sponsored and carried on under church authority. New Bethel Baptist Church, Goodlettsville, Tennessee, being the oldest in the Association was selected as the church to sponsor said work.

The recommendation of this committee was presented to New Bethel Baptist Church in regular Business Meeting on January 23, 1977. New Bethel Baptist Church unanimously accepted the recommendation and a committee composed of five members of the church known as "Missionary Baptist Literature Committee," was appointed and was authorized to get writers, have literature printed and distributed to the churches.

This committee has worked to get writers. Some have felt they could not continue and wished to be released from the heavy obligation, while others were found to replace them. At this date, we have all the Sunday School Quarterlies for the Spring Quarter (March, April, May 1978) complete in manuscripts and ready to go to press. We appreciate everyone who has assisted in this important work and wish to thank all the churches which sent donations to help with some of the initial expenses involved.

If our churches in the various Associations, and those of the same faith and order who may not be represented in an Association, will cooperate in ordering the literature and using same in their Sunday Schools, and the pastors and Sunday School superintendents will work together and encourage this work in their respective churches it will be a project of which we can be proud.

CONSTITUTION

Article I. This body shall be known as Wiseman Association.

Article II. These Associations shall be composed of members duly chosen

by regular and orderly Missionary Baptist Churches within our bounds.

Article III. The letters from churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated, and dead, since last annual meeting.

Article IV. Each Church shall be entitled to three messengers.

Article V. These Associations shall elect annually as officers, a Moderator, Clerk and Treasurer, whose duties shall be to serve their brethren in their several capacities.

Article VI. These Associations shall never interfere with the Independence of any Church, or claim any ecclesiastical power or rights of supervision over

any of the Churches.

Article VII. It shall be the object of these Associations to promote the union of the faith of the Gospel with our educational and mission interests.

Article VIII. These Associations shall meet annually on Friday at 10 o'clock A.M., after the third Sunday in October, and continue two days, the meetings to be held at such places as may be agreed upon by the Association at its annual sitting.

Article IX. A majority of the members of any regular meeting shall consti-

tute a quorum for the transaction of business.

Article X. It is expected that these meetings will be missionary in practice

as well as theory.

١

Article XI. New Churches may be admitted into the Association who shall petition by letter and messengers, and on examination, if found orthodox and orderly, may be received and made known by the Moderator giving the right hand of fellowship to the Messenger or Messengers present.

Article XII. The Association may exclude from the union any Church or

Churches that are heterodox in principle or disorderly in practice.

Article XIII. No proceedings shall be had against any Church except on charges preferred by a Sister Church, which shall first have followed the direction of Matthew 18:15, in attempting to bring it to repentance.

Article XIV. The Association, at its sitting may welcome any visiting brethren present, who shall have liberty to join in the discussion of any report listed in the Order of Business, but shall have no vote in any action of the

association.

Article XV. Any alteration may be made to this Constitution at any regular

meeting, by a majority vote of the members present.

Article XVI. That all questions arising before this Association be decided by a majority vote of the messengers present, except in the reception of churches into our fellowship, and that such reception be by a two-thirds vote of messengers present.
