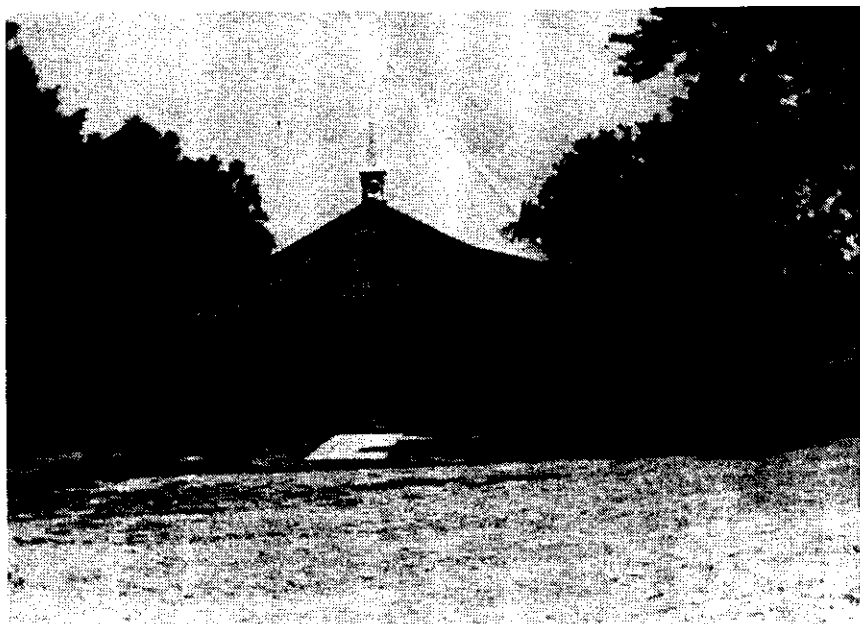

CONSTITUTION

Article I. This body shall be known as Wiseman Association.

Article II. These Associations shall be composed of members duly chosen by regular and orderly Missionary Baptist Churches within our bounds.

Article III. The letters from churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated, and dead, since last annual meeting.

Article IV. Each Church shall be entitled to three messengers.

Article V. These Associations shall elect annually as officers, a Moderator, Clerk and Treasurer, whose duties shall be to serve their brethren in their several capacities.

Article VI. These Associations shall never interfere with the Independence of any Church, or claim any ecclesiastical power or rights of supervision over any of the Churches.

Article VII. It shall be the object of these Associations to promote the union of the faith of the Gospel with our educational and mission interests.

Article VIII. These Associations shall meet annually on Friday at 10 o'clock A.M., after the third Sunday in October, and continue two days, the meetings to be held at such places as may be agreed upon by the Association at its annual sitting.

Article IX. A majority of the members of any regular meeting shall constitute a quorum for the transaction of business.

Article X. It is expected that these meetings will be missionary in practice as well as theory.

Article XI. New Churches may be admitted into the Association who shall petition by letter and messengers, and on examination, if found orthodox and orderly, may be received and made known by the Moderator giving the right hand of fellowship to the Messenger or Messengers present.

Article XII. The Association may exclude from the union any Church or Churches that are heterodox in principle or disorderly in practice.

Article XIII. No proceedings shall be had against any Church except on charges preferred by a Sister Church, which shall first have followed the direction of Matthew 18:15, in attempting to bring it to repentance.

Article XIV. The Association, at its sitting may welcome any visiting brethren present, who shall have the liberty to join in the discussion of any report listed in the Order of Business, but shall have no vote in any action of the Association.

Article XV. Any alteration may be made to this Constitution at any regular meeting, by a majority vote of the members present.

Article XVI. That all questions arising before this Association be decided by a majority vote, except in the reception of churches into our fellowship, and that such reception be by a two-thirds vote.

RULES OF DECORUM

1. The Association shall be opened and closed with prayer.
2. A Moderator, Clerk and Treasurer shall be chosen annually to serve the Association.
3. Only one person shall speak at a time, who shall arise and address the Moderator by the appellation of Brother Moderator, and shall, while speaking, confine himself to the subject under discussion and shall not be interrupted unless he digress from the subject; and shall in no wise reflect on any other speaker, so as to make remarks on his slips, failing or imperfections, but shall fairly state his views without sophistry or criticism.
4. No member shall absent himself from the Association without leave of the Moderator.
5. No member shall speak more than three times on the same subject without leave of the body. The chairman on each subject shall have an opening speech of ten minutes and two other speeches of five minutes each.
6. Each motion and second shall come under the immediate consideration of the Association, unless withdrawn by the one who made it.
7. No member shall address another by any appellation other than that of Brother.
8. On the first day, immediately upon permanent organization, it shall be the duty of the clerk to read the Rules of Decorum. A roll call of messengers shall be made on the second day.
9. The Moderator shall be entitled to the same privilege of speaking as any other member, providing the chair be filled, but shall have no vote unless the Association be equally divided.
10. Any member violating these rules, or at any time manifesting a spirit contrary to the Gospel shall be reprovod or such other course taken with him as the Moderator may think proper, either at his own option or the intimation of any other member.

FRIDAY – OCTOBER 16, 1984

On the above date, Wiseman Baptist Association convened in its 94th annual session with Cedar Grove Missionary Baptist Church, Woods Ferry Rd., Gallatin, Tennessee at 11:00 A.M.

Services began with singing led by Bro. Morris Watson, accompanied at the piano by Bro. Steven Turman. "Just A Little Talk With Jesus" and "What A Day That Will Be," were sung. The moderator made some preliminary remarks and welcomed all visitors who had come to be with us. He read Hebrews 1:1-8 for a Devotional and asked Elder Rex Hunt to lead the congregation in prayer. "I Feel Like Traveling On," was then sung.

Elder James E. Suttle, pastor of the host church, welcomed everyone to Cedar Grove Church for the 94th annual session of the Wiseman Association.

The moderator presented Elder Ray Sutton to preach the Introductory Sermon. Bro. Sutton expressed his appreciation for this opportunity, and requested the prayers of God's people. He read for a lesson, II Timothy 2:1-10. His text was taken from verse three of the lesson read, "A Good Soldier of Jesus Christ."

He began with reference to a soldier, as a pastor, when Jesus instructed Peter to feed his sheep and his lambs. Bro. Sutton said there were many mercenaries in the Lord's work, who labored for hire and not for the love of God, and love of God's cause.

As the speaker expanded on the thought, "What is a good soldier?" he explained that the first qualification for a good soldier of Jesus Christ, was to be a born-again child of God, Ephesians 2:8-9. The next qualification for a good soldier of Jesus Christ is to follow Christ in baptism, Acts 2:41; Acts 10:48.

Bro. Sutton, as he continued his discourse, said the next need of a good soldier of Jesus Christ was "to be taught" implying, of course, he must be willing to learn and prepare himself for the ministry in which he serves as a soldier.

David's meeting the challenge of Goliath was introduced, showing David's faith in God for his victory as a good soldier of faith as spoken of by the apostle Paul. In the army of God, and among the soldiers of Christ, there should not be any desire or preeminence. Scriptures referred to were III John 9; Colossians 1:18.

Bro. Sutton spoke of the change of the inward man, and how the outward man, which is not changed at the time of the new birth, would not enjoy the works and the life of a good soldier of Jesus Christ, but that the body is to be brought under submission to the nature and desires of the inward man in order to be a good soldier. He spoke of Nehemiah's return from captivity to Jerusalem and his desire and his work in rebuilding the walls of the city in the midst of persecution and false accusations. That this should be a lesson for us today in the service of God. Paul's statement in Ephesians 6:16, was quoted.

Bro. Sutton spoke of the persecutions of the Old Testament soldiers of God, reading from Hebrews, Chapters 11 and 12. He said many are "part-time soldiers and will get part-time blessings and pay." He spoke of the glory God is to receive through his church by Jesus Christ, Ephesians 3:21; Matthew 28:19-20. The message was closed by referring to John's statement in Revelation 5:12. This was a good sermon. While extending the right hand of fellowship to one another, the congregation extended their hand of fellowship and endorsement to Bro. Sutton for his message, while singing "Leaning On The Everlasting Arms," "Amazing Grace," "I'm In The Way" and "O How I Love Jesus."

After the church letters were filed with the clerk, the moderator appointed Elders Paul Bryson and Kenneth Massey as reading clerks.

MISSIONS

There was a motion and second to adopt the report.

The moderator introduced Elder James "Pete" Porter to preach the Memorial Sermon. Bro. Porter expressed his appreciation for the privilege, and requested the prayers of God's people. He read for a lesson I Thess. 4:13-18; Heb. 11:13-16. His subject was "Those Who Died In Faith." In the beginning of his message Bro. Porter pointed out the importance of faith, referring to I Cor. 15:19; Rom. 10:13-17; Isaiah 55:1; Rom. 8:11.

The speaker expounded upon the results of faith in Christ that brings salvation, and that the witness of this relationship is the Holy Spirit, Rom. 8:16. Again, Bro. Porter referred to Paul's writing on the resurrection of Christ and how, upon the basis of his resurrection, we, too, shall be raised from the dead.

He referred again to the lesson and the assurance Paul gave to the Thessalonians of life beyond the grave. He also used this in relationship to his reading from Hebrews 11. Other scriptures used here were Phil. 1:21; I Cor. 15:53-58.

Bro. Porter gave Rev. 21:1-3 and Rev. 14:13 as proof of the joy of God's people in heaven and how their works on earth continue. He finished his message by referring back once again to Heb. 11:13, "These all died in faith, not having received the promises, but having seen them afar off, and were persuaded of them, and embraced them, and confessed that they were strangers and pilgrims on the earth." The concluding scriptures were John 5:28-29; I Thess. 4:13-18.

In token of appreciation of this good Memorial Sermon, the congregation came extending their hand of fellowship to Bro. Porter, and to one another while singing "I'll Meet You In The Morning" and "That Glad Reunion Day."

FAITH AND PRACTICE OF TRUE BAPTISTS

To set forth briefly the Faith and Practice of True Baptists, we have only one book as our guide, the inspired word of God, II Timothy 3:16-17. By "the faith" of true Baptists we understand that to mean the one system of doctrine. We believe God foreknew that Adam would fall from his holy state, so, from before the foundation of the world, we believe Christ stood as a lamb slain for the redemption of all men.

We believe when the fulness of the time was come, God sent forth his Son, made of a woman, made under the law, to redeem them that were under the law, that we might receive the adoption of sons.

We believe the scriptures clearly teach us that Christ instituted his church with the material prepared by John the Baptist, who was sent from God for that very purpose. After the death, burial and resurrection of our Saviour he commissioned his church to carry his gospel message to every nation, and that repentance and remission of sins be preached in his name. With these orders his church has been preaching his one gospel, which is the power of God unto salvation to everyone that believeth, for these many centuries, and also illustrating this gospel by the two ordinances that Christ gave to the church, namely, baptism and the Lord's Supper, and these in the proper order.

We shall not attempt to enumerate the many truths and doctrines that are related to this great work, but would like to re-emphasize the importance of staying with God's plan, preach his word, call for and demand fruit meet for repentance, baptizing only those bringing fruit, and teach them to observe the things Christ has commanded.

Whenever this pattern is followed you can have a good sound Baptist Church that will glorify God. We believe there is only one God, one Saviour, one Spirit, one body, one plan of salvation and one baptism. So, let each of us renew our zeal to earnestly contend for the faith once delivered to the saints until our Saviour returns to receive his bride, and on the morning of the resurrection of the just we shall be caught up together to meet the Lord in the air. And so shall we ever be with the Lord.

This is a very important subject and should be the desire and duty of every Child of God to have a part in supporting and carrying the Word of God to a lost world.

We believe that in supporting the Lord's cause with the means which God has given us is a manifestation of our love for Him. "Honour the Lord with thy substance and with the firstfruit of all thine increase," Proverbs 3:9. Also in Psalms 116:12, "What shall I render unto the Lord for all his benefits toward me."

Our people have responded greatly in the past few years to this cause, but the need is still great to support our churches, pastors, missions, and missionaries that we might be able to stand with pride for our Lord against the wickedness of this world. "God loveth a cheerful giver," II Corinthians 9:7.

There are sins of commission and sins of omission. Jesus told the Church in Sardis to be watchful and strengthen the things which remain. Rev. 3:2.

The time arrived for the Doctrinal Sermon and the Order of Business was suspended until after lunch.

The congregation sang "I Can Tell You The Time" and the moderator introduced Elder A. G. Gregory to preach the Doctrinal Sermon. Bro. Gregory commended the Wiseman Baptist Association for the good harmony and fellowship that existed, and which had been for the past few years. He expressed his appreciation for the privilege to preach this sermon before the association.

Bro. Gregory read Rev. 19:6-9 for a lesson, and chose verse 7 for his text, "Let us be glad and rejoice, and give honour to him: for the marriage of the Lamb is come, and his wife hath made herself ready."

Bro. Gregory began his message by referring to the establishment of the Lord's church during his earthly ministry, and also the prophecy of the same by Daniel in Daniel 2:44. Scriptures given at this time referring to the bridegroom in his relationship to the bride were Matt. 9:15; John 3:29; II Cor. 11:2-3. He emphasized the need of

church attendance and support of God's cause for people to be happy and influential. He pointed out that church members who never attend church and who partake of the sins of the world cannot expect to be in the bride at the marriage of the Lamb, just because their church has not dealt with them. That the meaning of binding and loosing as spoken by Jesus in Matt. 18:18 had to be according to scriptural teaching and practice.

The speaker quoted Jesus' statement to the church at Ephesus in Rev. 2:4-5, on churches or church members returning to their first love and repenting of their errors. That to be in the bride, this must be done. Rom. 12:1 was quoted in relation to this principle.

Bro. Gregory spoke of the need of harmony in churches, quoting Psalm 133:1-2; Pro. 6:19. Other scriptures read, quoted or referred to were Gal. 5:19-21; Eph. 5:22-27. He then went back to his lesson in Rev. 19:7, urging us to contend for these scriptural principles, that we lose not the church in this area of the country as has happened in other countries.

True churches and those members meeting the scriptural qualifications will be the bride of Christ and all others who have been saved, and not in the bride, will be guests at the wedding. The growth of this kingdom (that is the church called the bride) is referred to in Psalm 72:16 and Rev. 21:1-27.

This truly was a good sound, well delivered, doctrinal sermon. Many hearty Amens were echoed throughout the message. In expressing appreciation of and an endorsement of the sermon, the congregation extended the right hand of fellowship to Bro. Gregory, and to one another while singing "What A Day That Will Be," "Heaven's Jubilee," "I Feel Like Traveling On," "Amazing Grace" and "I Just Began To Live."

Moved to adjourn one hour for lunch. Carried. After announcements, Elder Don Curtis prayed the benediction and offered thanks for the meal.

After another fine hour of fellowship, a bountiful meal and God's blessings upon us, we convened for the final service of the 94th annual session of the Wiseman Baptist Association. Services began with singing led by Bro. Bert Lanier accompanied at the piano by Bro. Bob Vanderpool. "Life's Evening Sun" and "Do You Know My Jesus?" were sung. The moderator expressed thanks and appreciation on behalf of the association to Cedar Grove Missionary Baptist Church for the splendid manner in the way they had entertained this body. He read John 1:29-34 for a Devotional and asked Bro. Luther Jent, a messenger from Denver, Colorado, to lead the congregation in prayer.

Business resumed with the discussion of the report on Church Discipline which was suspended before noon for the Doctrinal Sermon. The motion for adoption of the report carried after spoken to by Elder Raymond B. Sutton and Elder Paul Patterson.
