CONSTITUTION

Article I. This body shall be known as Wiseman Association.

Article II. These Associations shall be composed of members duly chosen by regular and orderly Missionary Baptist Churches within our bounds.

Article III. The letters from churches to the Association shall give the number of members in fellowship, received by experience and baptism, received by letter, restored, excommunicated, and dead, since last annual meeting.

Article IV. Each Church shall be entitled to three messengers.

Article V. These Associations shall elect annually as officers, a Moderator, Clerk and Treasurer, whose duties shall be to serve their brethren in their several capacities.

Article VI. These Associations shall never interfere with the Independence of any Church, or claim any ecclesiastical power or rights of supervision over any of the Churches.

Article VII. It shall be the object of these Associations to promote the union of the faith of the Gospel with our educational and mission interests.

Article VIII. These Associations shall meet annually on Friday at 10 o'clock A.M., after the third Sunday in October, and continue two days, the meetings to be held at such places as may be agreed upon by the Association at its annual sitting.

Article IX. A majority of the members of any regular meeting shall constitute a quorum for the transaction of business.

Article X. It is expected that these meetings will be missionary in practice as well as theory.

Article XI. New Churches may be admitted into the Association who shall petition by letter and messengers, and on examination, if found orthodox and orderly, may be received and made known by the Moderator giving the right hand of fellowship to the Messenger or Messengers present.

Article XII. The Association may exclude from the union any Church or Churches that are heterodox in principle or disorderly in practice.

Article XIII. No proceedings shall be had against any Church except on charges preferred by a Sister Church, which shall first have followed the direction of Matthew 18:15, in attempting to bring it to repentance.

Article XIV. The Association, at its sitting may welcome any visiting brethren present, who shall have the liberty to join in the discussion of any report listed in the Order of Business, but shall have no vote in any action of the Association.

Article XV. Any alteration may be made to this Constitution at any regular meeting, by a majority vote of the members present.

Article XVI. That all questions arising before this Association be decided by a majority vote, except in the reception of churches into our fellowship, and that such reception be by a two-thirds vote.

Article XVII. If any church fails to represent one or more years, and then desires to reenter the fellowship of this association, there being, evidently, a reason for not representing, there must be a motion for their reentering the Association to be carried by a two-thirds vote. This action is to be taken after permanent organization and at the time to receive petitionary letters.

RULES OF DECORUM

1. The Association shall be opened and closed with prayer.
2. A Moderator, Clerk and Treasurer shall be chosen annually to serve the Association.
3. Only one person shall speak at a time, who shall arise and address the Moderator by the appellation of Brother Moderator, and shall, while speaking, confine himself to the subject under discussion and shall not be interrupted unless he digress from the subject; and shall in no wise reflect on any other speaker, so as to make remarks on his slips, failing or imperfections, but shall fairly state his views without sophistry or criticism.
4. No member shall absent himself from the Association without leave of the Moderator.
5. No member shall speak more than three times on the same subject without leave of the body. The chairman on each subject shall have an opening speech of ten minutes and two other speeches of five minutes each.
6. Each motion and second shall come under the immediate consideration of the Association, unless withdrawn by the one who made it.
7. No member shall address another by any appellation other than that of Brother.
8. On the first day, immediately upon permanent organization, it shall be the duty of the clerk to read the Rules of Decorum. A roll call of messengers shall be made on the second day.
9. The Moderator shall be entitled to the same privilege of speaking as any other member, providing the chair be filled, but shall have no vote unless the Association be equally divided.
10. Any member violating these rules, or at any time manifesting a spirit contrary to the Gospel shall be reprovved or such other course taken with him as the Moderator may think proper, either at his own option or the intimation of any other member.

NEW HAMPSHIRE CONFESSION OF FAITH

I. OF THE SCRIPTURES

We believe that the Holy Bible was written by men divinely inspired, and is a perfect treasure of heavenly instruction: that it has God as its author, salvation for its end, and truth without any mixture of error, for its matter; that it reveals the principles by which God will judge us; and therefore is, and shall remain to the end of the world, the true center of Christian union, and the supreme standard by which all human conduct, creeds, and opinions should be tried.

We believe that man was created in holiness, under the law of his Maker; but by voluntary transgressions fell from that holy and happy state; in consequence of which all mankind are now sinners not by constraint, but choice; being by nature utterly void of that holiness required by the law of God, positively inclined to evil; and therefore under just condemnation to eternal ruin, without defense or excuse.

We believe that the salvation of sinners is wholly of grace; through the mediatorial offices of the Son of God; who by the appointment of the Father, freely took upon him our nature, yet without sin; honored the divine law by his personal obedience, and by his death made a full atonement for our sins; that having risen from the dead he is now enthroned in heaven; and uniting in his wonderful person the tenderest sympathies with divine perfections, he is every way qualified to be a suitable, a compassionate, and an all-sufficient Saviour.

V. OF JUSTIFICATION

We believe that the great gospel blessing which Christ secures to such as believe in him is Justification; that Justification includes the pardon of sin, and the promise of eternal life on principles of righteousness; that it is bestowed, not in consideration of any works of righteousness which we have done, but solely through faith in the Redeemer's blood; by virtue of which faith his perfect righteousness is freely imputed to us of God; that it brings us into a state of most blessed peace and favor with God, and secures every other blessing needful for time and eternity.

We believe that Christian Baptism is the immersion in water of a believer, into the name of the Father, and Son, and Holy Ghost; to show forth, in a solemn and beautiful emblem, our faith in the crucified, buried, and risen Saviour, with its effects in our death to sin and resurrection to a new life; that it is prerequisite to the privileges of a church relation; and to the Lord's Supper; in which the members of the church, by the sacred use of bread and wine are to commemorate together the dying love of Christ; preceded always by solemn self-examination.

FRIDAY – OCTOBER 23, 1987

The Wiseman Baptist Association convened in its 97th annual session on Friday, October 23, 1987, at 10:00 A.M. with West End Missionary Baptist Church, 440 West Main Street, Gallatin, Tennessee.

Services began with singing led by Elder W. R. Overton accompanied at the piano by Sister Helen Perrigo. Song selections were "My Loved Ones Are Waiting For Me" and "The Life Boat". The moderator made remarks relative to our meeting, its purpose and the joy of fellowship. Visitors were welcomed. Among those visiting with us were Elder and Mrs. Calvin Perrigo, Elder Tim Binion, Bethel Association; Elder and Mrs. Rex Hunt, Elder Jerry Reynolds, Siloam Association; Bro. and Mrs. Gayler Mustain, Polk County Association; Elder Bobby Randolph, Sister Edith Randolph, Bro. Billy Wayne White, Sister Patsy White, Big Bear Creek Missionary Baptist Association in Alabama.

The clerk has tried to recognize visitors in the services that they attended. See minutes of Friday night and Saturday sessions for other visitors.

The moderator read for a devotional, Phillipians 1:1-7. Elder Benny Maggart led the congregation in prayer. Following the prayer the congregation sang "I Am Going To That City." Elder William E. Massey, pastor of host church, welcomed the association to West End. The moderator presented Elder Terry Lyles to preach the Introductory Sermon.

Bro. Lyles made introductory remarks asking for the prayers of God's people. He read for his lesson, Psalm 133:1-3. His subject was "Sonship, Fellowship and Discipleship."

SONSHIP: Scriptures given in the beginning of the message were John 1:12-13 and Romans 8:14; 16-17, which speaks of our being heirs of God and joint heirs with Christ. Being the sons of God, he chastises us because of his love for us, Hebrews 12:6-9. He spoke of the church's authority of sending out ministers to preach the gospel whereby lost souls can hear and be saved, Romans 10:13-17, becoming sons of God.

FELLOWSHIP: Bro. Lyles then spoke of the fellowship with God. He referred to those who have experienced Sonship, but are out of fellowship with God. He spoke of the sweet, spiritual fellowship that we can have with God, and that by God's grace, whereby we cry, Abba Father. He quoted I Corinthians 1:9-10 where Paul spoke of our fellowship as brothers and sisters in the church. He emphasized the fact that to be in fellowship with God and our brothers and sisters was more than just being saved. Other scriptures given here were II Corinthians 6:14, Psalm 51 and I John 1:5-10.

DISCIPLESHIP: The introductory scriptures given here were John 8:31-32 and John 13:34-35, teaching God's love is needful, and should be manifested to truly be recognized as a true disciple of Christ. 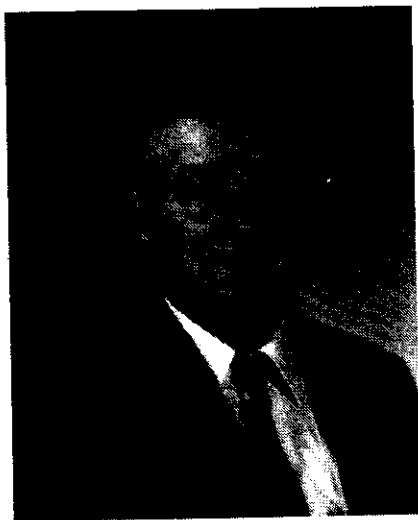

THE CAUSE OF THE COLDNESS OF OUR CHURCHES AND THE SCRIPTURAL REMEDY

I do believe there is a lack of concern, having no vision of the lost, a pessimistic attitude, or lack of faith, therefore our works are few.

Many times we try to measure the results of our labors, when we are told to not be weary in the well doing and we shall reap in due season if we faint not—leave the results in the hand of God. He has said his word would not return unto him void, but it shall accomplish that which I please, and it shall prosper in the thing whereto I sent it.

THE REMEDY

First of all, it is impossible to please God without faith. It is impossible to have faith and not be optimistic (belief that good ultimately prevails over evil). The scriptural remedy can be summed up in three words—prayer, cooperation, and work.

The book of Nehemiah tells us that Nehemiah was concerned over the condition of Jerusalem, the place of his fathers. We should be concerned about our churches. (Nehemiah 1:6 and 11) He turned to God in prayer, seeking the wisdom and power

of God, prayer of intercession for Israel, prayer of confession for Israel and himself. He began by asking the help of God. The people joined him in the work. (Nehemiah 2:17 and 18) He surveyed the wall, he recognized the desolation, and he inspired the people. There was no weakness or self-pity. They had a mind to work.

The remedy is prayer, cooperation and work.

CHURCH AND PASTOR RELATIONSHIP AND THEIR DUTIES TO EACH OTHER

Christ left His Church here on earth to carry out the commission and has called ministers to preach the gospel and led them by the Holy Spirit to pastor His Churches. Matthew 20:16. Matthew 4:19 "And He saith unto them, Follow me, and I will make you fishers of men."

Paul says in I Cor. 3:9 "For we are labourers together with God: Ye are God's husbandry, ye are God's building." To have a working relationship, the Church and the pastor must realize their responsibilities to God.

A GOOD PASTOR MUST BE AWARE OF:

1. The spiritual needs of the congregation—Who is saved and who is unsaved in each family.
2. The ability of the members of the church in leadership.
3. In a proper church and pastor relationship, the pastor is to be the servant of the church, not the boss or the dictator.

SOME IMPORTANT DUTIES OF THE PASTOR ARE AS FOLLOWS:

their problems in confidence.

9. To use the help of all willing members in visitation, prayer meeting, etc.

DRUG AND ALCOHOL ABUSE AND ITS EFFECT ON OUR SOCIETY

If we pause to think for a moment of the title of our report, a common response might be "What is this world coming to? We didn't have this problem a few years ago." While this response might be common, the truth of the matter is that since the very dawn of time, members of our society have abused alcohol and for hundreds of years, members of our society have abused drugs.

The Wise Man Solomon in his Proverbs, warns us of the sadness this can cause; but yet drug and alcohol abuse is ever increasing. In order to combat the problem, we must seek to understand why and the answer to this question is not simple. Much of it, however, is contributed to a personal desire on the part of an individual to be better or different than what they perceive themselves to be. This overwhelming desire is often accompanied with intense peer pressure which leads the individual to turn to chemical substances, and for a moment turn their fantasy into reality.

The consequences of this fantasy are staggering. Every day, 80 people are killed. Every day, 3,000 people are injured. Every day, 15 people commit suicide. Every day, 400 homes are broken and 250 people beat their children or loved ones. All this sadness and heartache at a cost of 27 million dollars per day so that an individual can be someone else for a moment.

The question remains, "Is it really worth it?" I think not. What we hear and see, though, is a cry from the masses, a cry for us to let them know that Christ died for them just as they are, and when they find him, they will experience what the Apostle Paul tells the Corinthian church—all things will become now and former things will be passed away. There will never be a problem He can't handle and He will never be too busy to hear.

How is this accomplished? Before the Lord returned to Heaven, He gave us—the Church—a great commission: to carry the gospel out into the world. We must be about our Father's business to see that the lost and dying hear of this wonderful Saviour. In addition, we must educate ourselves and the communities we serve of the devastating effects of drug and alcohol abuse. This is part of our responsibility as a church of the true and living God.

We must also ourselves exhibit dependence on something that lasts forever. This will show the world some of the most important benefits of salvation: love, concern and compassion for the masses.
